- 18 **(2) Have no disciplinary history with the board.**
- 19 **(3) Be eligible to provide supervised clinical services, mentor trainees, or**
20 **participate in board-approved supervision structures.**
- 21 **(4) Demonstrate competency in:**
- 22 **(a) Addiction counseling and recovery-oriented care.**
- 23 **(b) Co-occurring disorder treatment.**
- 24 **(c) Evidence-based behavioral health practices.**
- 25 **(5) Have familiarity with Louisiana's behavioral health infrastructure, including**
26 **state agencies, parish level services, and community based recovery networks.**

33 On page 20, after line 28, insert the following:

34 "Section 3.(A) The Addictive Disorder Regulatory Authority shall coordinate with
35 the Louisiana Department of Health during the transition of peer support specialists from the
36 department to the board.

37 (B) Any rules promulgated by the Addictive Disorder Regulatory Authority relative
38 to peer support specialist associates, peer support specialists, and peer support supervisors
39 shall align with the Substance Abuse Mental Health Services Administration's (SAMHSA)

- 1 National Model Standards for Peer Support Certification in accordance with any federal
- 2 requirements by the Centers for Medicare and Medicaid Services (CMS)."
