9 **§3083. Rule of construction**

10 **This Part shall be construed and applied in a manner consistent with**
11 **federal law and shall not be interpreted or enforced to prohibit, restrict,**
12 **condition, or delay any transaction, agreement, activity, technology, software,**
13 **service, or access that has been authorized, approved, licensed, exempted, or**
14 **otherwise permitted by the United States government.**"

15 AMENDMENT NO. 5

16 On page 2, line 7, change "**§3083.**" to "**§3084.**"

17 AMENDMENT NO. 6

18 On page 3, line 5, after "**completed**" delete the remainder of the line, delete line 6, and insert
19 a period " . "

26 **"controlled, directly or indirectly, by persons or entities of a foreign adversary**
27 **through the ownership of a majority voting interest or the power to direct**
28 **management or policies of the entity. Ownership shall not include passive**
29 **ownership of publicly traded securities that does not confer the power to direct**
30 **or influence management or operations.**"

31 AMENDMENT NO. 10

32 On page 3, between lines 26 and 27, insert the following:

33 **"(8) "Operational command authority" shall mean the authority to**
34 **direct, control, or make real time operational decisions affecting the physical**
35 **functioning, safety, or emergency response of critical infrastructure.**"

2 On page 3, at the beginning of line 27, change "**(8)**" to "**(9)**"

20 **and in compliance with a license, authorization, approval, exemption, or**
21 **determination issued by the United States government, including but not limited**
22 **to licenses or approvals issued by the U.S. Department of Homeland Security,**
23 **U.S. Department of the Treasury, or U.S. Department of Commerce."**

27 On page 7, at the beginning of line 1, change "**§3087.**" to "**§3086.**"

31 On page 7, line 10, after "**R.S. 51:3086(A) or (B)**" and before the period "." insert the

33 **"unless the software was lawfully installed prior to August 1, 2026, and remains**
34 **compliant with applicable federal law"**

36 On page 7, delete lines 17 through 29, and on page 8, delete lines 1 through 6

37 AMENDMENT NO. 23

38 On page 8, between lines 6 and 7, insert the following:

39 **"§3087. Telecommunications providers in compliance with federal law.**
40 **Nothing in this Part shall apply to any provider of an interactive**
41 **computer service, as defined in 47 U.S.C. 230, or any provider of a**
42 **telecommunications service or an information service, as defined in 47 U.S.C.**
43 **153, nor to any employee, agent, or contractor acting on behalf of such provider,**
44 **to the extent such provider is in compliance with the Secure and Trusted**
45 **Communications Networks Act of 2019.**
46 **§3088. Electric utilities in compliance with federal law.**

1 **Nothing in this Part shall apply to any investor owned utilities subject to**
2 **the North American Electric Reliability Corporation (NERC) Reliability**
3 **Standards, or to any investor owned utility assets subject to the Nuclear**
4 **Regulatory Commission (NRC)**"

5 AMENDMENT NO. 24

6 On page 8, delete line 8 and insert the following:

7 **"A. Subject to appropriation, the Foreign Adversary Fraud Office (FAFO) shall**
8 **be created within"**

10 On page 8, delete lines 21 through 29, and on page 9, delete lines 1 through 4
