Provides for rights of private action for certain dealers and trade associations. (2/3-CA7s2.1(A)) (gov sig)

Proposed law amends the Louisiana Motor Vehicle Commission Law to provide licensed motor vehicle dealers and qualifying trade associations with a private right of action to enforce dealer regulations. Proposed law authorizes civil actions against manufacturers, distributors, or other covered entities, including claims for declaratory relief, injunctive relief, actual damages, treble damages in cases of willful or bad-faith violations, and recovery of costs and attorneys' fees. Proposed law modifies licensing procedures, allowing certain transfers and amendments of dealer licenses without prior Commission approval. Proposed law retains the current fee and penalty framework for dealer and manufacturer licensing, with clarifications and technical updates.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Any costs associated with implementation, including updates to administrative procedures, staff training, and minor information technology modifications, are expected to be minimal and absorbed within existing agency resources. OMV anticipates incorporating the required modifications into its CHAMP system (Drive360).

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. Proposed law retains current licensing fee structures, and does not abolish or waive fees under present law. Because the bill does not change fee amounts or collections, it is unlikely to have a revenue impact. However, any shift toward increased litigation or administrative amendments could affect fee timing or frequency, but exact impacts would be difficult to quantify at this stage.
