1 (i) A group of two or more hospitals that are owned, operated, sponsored, or
2 managed by a single entity, or that are subject to the control and direction of a common
3 owner or parent company.

4 (ii) Any parent entity, holding company, or affiliated group of entities under
5 common ownership or control that owns, operates, manages, or is affiliated with one
6 or more hospitals, clinics, physician practices, or other healthcare providers.

7 ~~(b)~~(c) "Licensee" means an individual who possesses a license, certificate, or
8 registration duly issued by a board, or an individual who has made application for such a
9 license, certificate, or registration.

10 (d) "Records and proceedings" shall mean and include, without limitation, all
11 records, notes, data, reports, memoranda, analyses studies, exhibits, minutes, draft
12 documents, emails, electronic communications, and work product generated by, for,
13 or at the direction of a committee covered by this Section.
