4 On page 1, delete lines 17 and 18 in their entirety and insert in lieu thereof the following:

5 "per insurer, person, or entity, up to one ~~hundred thousand~~ million dollars aggregate  
6 for all violations in a calendar year per insurer, person, or entity, ~~when~~ if such violations"7 AMENDMENT NO. 3

8 On page 1, line 21, after "any" and before "action" delete "such"

9 AMENDMENT NO. 4

10 On page 2, delete line 15 in its entirety and insert in lieu thereof the following:

11 "and up to ~~one hundred thousand~~ one million dollars aggregate for all violations in

14 On page 2, at the beginning of line 16, insert "year."

22 On page 3, delete lines 9 and 10 in their entirety and insert in lieu thereof the following:

23 "for each violation. No fine or fines shall be imposed against a lessor, pursuant to  
24 this Section, which aggregates in excess of ~~ten~~ one hundred thousand dollars in any calendar

27 On page 3, delete lines 15 and 16 in their entirety and insert in lieu thereof the following:

28 "exceed five hundred dollars for each violation occurring, up to ~~ten~~ one hundred

32 On page 3, delete lines 22 and 23 in their entirety and insert in lieu of thereof the following:

1 "not to exceed five hundred dollars for each violation up to ~~ten~~ one hundred thousand  
2 dollars aggregate for all violations in a calendar year, unless a fine is established by  
3 separate"
