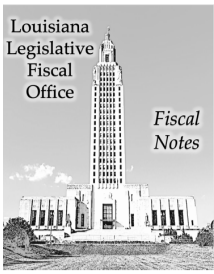

STUDENT/LOANS-SCHOLARSHIP RE INCREASE GF EX See Note Page 1 of 1  
 Authorizes scholarships provided for firefighters injured in the line of duty and spouses of firefighters injured or killed in the line of duty to be used for a master's degree

Present law provides for scholarships for the following categories of people: (1) A firefighter who is injured in his line of duty in which injury results in the inability to remain employed. (2) The spouse of a firefighter who is killed in the line of duty or injured in the line of duty and which injury results in the inability to remain employed. (3) A police officer who is injured in his line of duty in which injury results in the inability to remain employed. (4) The spouse of a police officer who is killed in the line of duty or injured in the line of duty and which injury results in the inability to remain employed. Present law requires each scholarship recipient to meet all entrance requirements to the college or university to which he applies, and to maintain a "C" average each semester. Requires scholarship to cover all tuition and fees. Proposed law retains present law. Present law limits use of scholarship to obtaining one bachelor degree. Proposed law adds an option to use the scholarship to obtain one bachelor's, master's, doctoral, or other postgraduate degree.

**EXPENDITURE EXPLANATION**

There will be an increase in SGF expenditures associated with the scholarships for certain firefighters and police officers injured in the line of duty and certain spouses of firefighters and police officers. The actual amount needed to fund the expanded scholarship program is indeterminable at this time and will vary from year to year depending on the number of eligible students applying, which institutions they choose to attend, and whether they elect to pursue a graduate degree rather than, or in addition to, a bachelor's degree. However, the LFO anticipates minimal utilization of this expanded scholarship, as demand for the existing bachelor's degree scholarship has been low. The LSU system reports only 2 recipients over the past five years, and SUNO reports no recipients in the past two years.


Note: The total cost of a master's degree at Louisiana public universities ranges from \$14,000 to \$68,000, varying by institution and program. The cost of a doctoral degree can be up to \$81,000.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. However, postsecondary institutions could see a decrease in self-generated revenues should eligible students who would otherwise pay tuition and fees pursue a postgraduate degree under the expanded exemption.
