Authorizes the Louisiana Commission on Law Enforcement and the Administration of Criminal Justice to establish a grant program for pursuit intervention technologies

Proposed law creates the Law Enforcement Pursuit Safety and Technology Grant Program within the Louisiana Commission on Law Enforcement and the Administration of Criminal Justice (LCLE) for the development of training and technology to safely terminate high-speed vehicle pursuits; requires the commission to administer the program based on the uniform guidelines promulgated by the commission; requires the funds be used for pursuit intervention training or the purchase of pursuit intervention technology and devices to enhance pursuit safety, including but not limited to GPS tracking projectiles, vehicle-stopping nets or tethering systems, such as the Grappler, and remote-controlled tire deflation devices; authorizes the commission to receive funds, grants, donations, or other assistance from any source, including federal funds and funds from the Louisiana Department of Transportation and Development for purposes of the program; requires the commission prioritize grant applications from agencies that have integrated pursuit technologies into policy that emphasize law enforcement safety by reducing manual deployment risks; is designated as the "Sergeant Grant Candies Officer Safety Act".

**EXPENDITURE EXPLANATION**

Proposed law will result in an increase of \$361,582 SGR out of the Pursuit Safety and Officer Technology Fund for the Louisiana Commission on Law Enforcement and the Administration of Criminal Justice (LCLE) to implement the Law Enforcement Pursuit Safety and Technology Grant Program. LCLE reports they will need an additional T.O. position, a Law Enforcement Training Consultant, to oversee implementation and ongoing administration of the grant program. The table below presents the estimated costs for the position with associated expenses including operating expenses (office space, technology needs, and office supplies), professional services, and equipment (a computer, monitor, and printers). Salaries increase by 4% annually for market rate adjustments.

Note: HB 873 creates the Pursuit Safety and Officer Technology Fund Account, provides for a revenue source for the fund, and allows LCLE to use not more than 5% of the annual fund balance for administrative costs. To the extent HB 873 is not enacted or the increases presented above exceeds 5% of the fund balance allowed for administrative expenses, LCLE may require SGF.
