SUPPLEMENTAL PAY OR -\$194,400 GF EX See Note Page 1 of 1
Prohibits law enforcement officers employed by a public postsecondary education institution from receiving state supplemental pay

Proposed law removes eligibility for state supplemental pay for law enforcement officers employed by public postsecondary education institutions. Present law provides supplemental pay to certain qualifying law enforcement officers, funded by the state, as an addition to base salary. Proposed law retains present law but excludes law enforcement officers employed by public postsecondary education institutions from eligibility for such supplemental pay.

EXPENDITURE EXPLANATION

Proposed law is anticipated to decrease SGF expenditures by approximately \$194,400 annually in Other Requirements Schedule 20-966 - Supplemental Pay. Current law provides supplemental pay to eligible law enforcement officers, including campus police officers employed by public postsecondary education institutions in the amount of \$600 per month (\$7,200 annually) per officer.

According to the Department of Public Safety – Supplemental Pay, the number of affected officers is as follows:

- 8 officers - McNeese State University
- 9 officers - University of New Orleans
- 10 officers - Southern University at New Orleans
- 27 officers - Total


The proposed law removes eligibility for these officers, resulting in an estimated reduction of 27 officers receiving supplemental pay. This change is projected to reduce SGF expenditures by \$194,400 annually (27 officers × \$600 × 12 months).

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
