COMMERCIAL REGULATIONS. Provides relative to certain acts on a licensed establishment. (8/1/26)

1 AN ACT

2 To amend and reenact R.S. 26:90(A)(3)(a) and 286(A)(3)(a), relative to alcoholic beverage
3 permits; to provide for acts prohibited on licensed premises; to prohibit enticement
4 of minors on premises with certain substances; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 26:90(A)(3)(a) and 286(A)(3)(a) are hereby amended and reenacted
7 to read as follows:

8 §90. Acts prohibited on licensed premises; suspension or revocation of permits

9 A. No person holding a retail dealer's permit, and no person permitted to sell
10 alcoholic beverages at retail to consumers, and no agent, associate, employee,
11 representative, or servant of any such person shall do or permit any of the following
12 acts to be done on or about the licensed premises:

13 * * *

14 (3)(a) Intentionally entice, aid, or permit any person under the age of eighteen
15 years to visit or loiter in or about any place where alcoholic beverages ~~or beer~~, **beer**,
16 **or consumable hemp products as defined in R.S. 3:1481** are the principal
17 commodities sold, handled, or given away. The provisions of this Section shall in no

1 way prohibit the presence of any person under the age of eighteen years on or about
 2 a licensed premises for any function sponsored by a religious or charitable
 3 organization with tax exempt status under Section ~~501(3)~~ **501(c)(3)** of the Internal
 4 Revenue Code of the United States, or by a fraternal beneficiary society with tax
 5 exempt status under ~~501(8)~~ **501(c)(8)** of the said code, and no alcoholic beverages
 6 are sold, handled, given away, or accessible during the presence of any such person.

8 §286. Acts prohibited on licensed premises; suspension or revocation of permits

9 A. No person holding a retail dealer's permit, and no person permitted to sell
 10 alcoholic beverages at retail to consumers, and no servant, agent, or employee of the
 11 permittee shall do any of the following acts upon the licensed premises:

13 (3)(a) Intentionally entice, aid, or permit any person under the age of eighteen
 14 years to visit or loiter in or about any place where alcoholic beverages ~~or beer~~ **, beer,**
 15 **or consumable hemp products as defined in R.S. 3:1481** are the principal
 16 commodities sold, handled, or given away. However, the provisions of this Section
 17 shall in no way prohibit the presence of any person under the age of eighteen years
 18 on or about a licensed premises for any function sponsored by a religious or
 19 charitable organization with tax exempt status under Section ~~501(3)~~ **501(c)(3)** of the
 20 Internal Revenue Code of the United States, or by a fraternal beneficiary society with
 21 tax exempt status under ~~501(8)~~ **501(c)(8)** of the said code, and no alcoholic
 22 beverages are sold, handled, given away, or accessible during the presence of any
 23 such person.

Present law prohibits any person holding an alcoholic beverage retail dealer's permit of high

or low alcoholic content, and any person permitted to sell alcoholic beverages at retail to consumers, including their agents, associates, employees, representatives, or servants from intentionally enticing, aiding, or permitting any person under the age of 18 years from visiting or loitering in or about any place where alcoholic beverages or beer are the principal commodities sold, handled, or given away.

Proposed law retains present law and adds locations where consumable hemp products are sold, handled, or given away, to the list of locations where persons under the age of 18 years are prohibited from visiting or loitering.

Effective August 1, 2026.
