Provides relative to the filing of electronic records. (8/1/26)

Current law provides for authorization of clerks of court, ex officio recorders, and registers of conveyances and recorders of mortgages throughout the state relative to making additional copies, purchasing or leasing equipment for photorecording, photocopying, microfilming, and electronic imaging, and defraying costs associated with copying, reproducing, and retrieving records out of any funds available in the clerk's salary fund; provides for destruction of criminal records; provides for rules on photostatic, photographic, microfilm, and other photographic or electronic copies of records; provides that no cause of action for any claim shall exist against a clerk of court for any damage or loss resulting from the return or destruction of an original record. Proposed law specifies district clerks of court and removes registers of conveyances and recorders of mortgages as clerks to which current law applies; authorizes district clerks of court and ex officio recorders to purchase software and services used to convert records into an electronic record as equipment they are permitted to use clerk's salary funds to purchase; removes nonrewritable magnetic, optical, and laser-type storage media as storage media used to retain copies of criminal records; provides that all rules adopted by the Department of State on retention and storage of records of public bodies shall apply to all records provided in current law and that each clerk shall maintain a locally available copy of records destroyed.
