5 platform is centered on human trafficking awareness and advocacy; she is committed to  
6 policy reform and victim protection; and

7           WHEREAS, Ms. Hill is actively engaged in numerous civic and philanthropic  
8 initiatives; she is a member of Alpha Kappa Alpha Sorority, Incorporated, and continues to  
9 serve in leadership roles that advance community connection and service; and
