AMENDMENT NO. 1

On page 1, at the beginning of line 2, after "To" and before "enact" insert "amend and reenact R.S. 44:4.1(B)(35) and to"

AMENDMENT NO. 2

On page 1, at the beginning of line 3, after "phase" and before "contracts" delete "and supply"

AMENDMENT NO. 3

On page 1, line 5, after "projects" and before the semicolon ";" delete "and procurement"

AMENDMENT NO. 4

On page 1, delete lines 6 and 7 in their entirety and insert "low-bid, best value, and qualifications based ID/IQ construction phase contracts; to"

AMENDMENT NO. 5

On page 1, delete line 9 in its entirety, insert "to provide for confidentiality of the evaluation process; to provide for contract term limits; to provide for"

AMENDMENT NO. 6

On page 1, between lines 11 and 12, insert the following:

"Section 1. R.S. 44:4.1(B)(35) is hereby amended and reenacted to read as follows:

§4.1. Exceptions

B. The legislature further recognizes that there exist exceptions, exemptions, and limitations to the laws pertaining to public records throughout the revised statutes and codes of this state. Therefore, the following exceptions, exemptions, and limitations are hereby continued in effect by incorporation into this Chapter by citation:

AMENDMENT NO. 8

On page 1, at the end of line 13, delete "and supply"

2 On page 1, line 18, after "provisions of" and before "of the Louisiana" delete "Titles 38,39.  
3 or 49" and insert "Titles 38 or 49"

4 AMENDMENT NO. 10

5 On page 2, delete line 1 in its entirety and insert "of 1950, if the authority determines it is  
6 in the best interest of the public,"

7 AMENDMENT NO. 11

8 On page 2, line 3, after "contracts" and before "pursuant" delete "and supply contracts"

9 AMENDMENT NO. 12

10 On page 2, at the end of line 5, insert the following:

12 "Indefinite Delivery, Indefinite Quantity contracting is a method of contracting that  
13 allows for delivery of an indefinite quantity of services over a fixed duration."

14 AMENDMENT NO. 13

15 On page 2, at the end of line 11, delete the period "." and insert "and includes any selection  
16 process authorized by applicable federal law."

17 AMENDMENT NO. 14

18 On page 2, delete lines 12 through 19 in their entirety and insert the following:

19 "(2) "Indefinite Delivery, Indefinite Quantity construction phase contract",  
20 or "ID/IQ construction phase contract" mean the contract awarded to an ID/IQ  
21 contractor pursuant to the requirements of this Section."

23 On page 2, at the beginning of line 20, delete "(4)" and insert "(3)"

24 AMENDMENT NO. 16

25 On page 2, delete lines 22 through 28 in their entirety and on page 3 delete lines 1 through  
26 5 in their entirety and insert the following:

27 "(4) "Multiple award" means an ID/IQ procurement where awards of ID/IQ  
28 construction phase contracts for the same scope of services are made to multiple  
29 ID/IQ contractors through a single procurement.

30 (5) "Single award" means an ID/IQ procurement where award of the ID/IQ  
31 construction phase contract is made to a single ID/IQ contractor."

32 AMENDMENT NO. 17

33 On page 3, at the beginning of line 6, delete "(8)" and insert "(6)"

34 AMENDMENT NO. 18

35 On page 3, delete lines 11 through 28 in their entirety and on page 4, delete line 1 in its  
36 entirety and insert the following:

1           "C. Where federal law applies, the authority shall comply with all applicable  
 2 federal laws or regulations including but not limited to 48 CFR Part 16, Subpart 16.5  
 3 and 48 CFR Part 216, Subpart 216.5, as amended. In the event of a conflict between  
 4 applicable required federal laws or regulations and the provisions of Titles 38 or 49  
 5 of the Louisiana Revised Statutes of 1950, or any other Louisiana rules or  
 6 regulations, the federal laws or regulations shall control.

7           D. Procurements pursuant to this Section may include single award or  
 8 multiple award ID/IQ construction phase contracts. The authority may use low bid,  
 9 best value, or qualifications based contracting methods as set forth in Subsection E  
 10 of this Section. Materials separately acquired by the authority may be provided to  
 11 contractors for use pursuant to and as a condition of any contract for an integrated  
 12 coastal protection project.

13           E. Procurement and award ID/IQ construction phase contracts shall meet the  
 14 following requirements:

15           (1)(a) Single award ID/IQ phase contracts awarded"

18 On page 4, line 7, after "provisions of" and before "this Subsection" delete "Paragraph (3)  
 19 of"

20 AMENDMENT NO. 20

21 On page 4, delete lines 8 through 29 in their entirety and on page 5 delete lines 1 through 4  
 22 in their entirety and insert the following:

23           "(b) Single award ID/IQ construction phase contracts awarded on a best value  
 24 basis shall follow the requirements for advertisements and the procedures set forth  
 25 in this Subsection.

26           (2) Multiple award ID/IQ construction phase contracts shall be awarded on  
 27 a qualifications basis and shall follow the requirements for advertisements and the  
 28 procedures set forth in this Subsection.

29           (3)(a) Prior to the award of any multiple award ID/IQ construction phase  
 30 contract or a single award ID/IQ construction phase contract not advertised pursuant  
 31 to R.S. 38:2212, the authority shall issue a "notice of intent", hereafter referred to in  
 32 this Section as "NOI", through advertisement on its designated webpage to request  
 33 letters of interest, hereafter referred to in this Section as "LOI". The NOI shall be  
 34 advertised a minimum of ten business days prior to the deadline for receipt of  
 35 responses. The NOI shall contain a description of the ID/IQ services to be procured.  
 36 The authority may additionally advertise the NOI via additional media or  
 37 publications, and may readvertise by any of the foregoing means to solicit additional  
 38 responses if the authority deems the number of responses received to be inadequate  
 39 to encourage competition.

40           (b)(i) After expiration of the deadline to submit an LOI for a single award  
 41 ID/IQ construction phase contract, the authority shall issue "request for proposals",  
 42 hereafter referred to in this Section as "RFP", to contractors that submit an LOI. The  
 43 RFP shall include instructions for development and submittal of proposals, a  
 44 description of how proposals shall be evaluated, and shall comply with the  
 45 requirements of this Section.

46           (ii) After expiration of the deadline to submit an LOI for multiple award  
 47 ID/IQ construction phase contract, the authority shall issue a request for  
 48 qualifications, hereafter referred to in this Section as "RFQ", to contractors that  
 49 submit an LOI. The RFQ shall include instructions for development and submission  
 50 of qualifications, a description of how qualifications shall be evaluated, and shall  
 51 comply with the requirements of this Section.

52           (c) Bid security required by R.S. 38:2218 or by the authority shall be  
 53 specified in the"

1 AMENDMENT NO. 21

2 On page 5, delete lines 7 through 13 in their entirety and insert the following:

3 "(4)(a) The executive director shall establish an evaluation committee for  
4 evaluation of proposals for best value single award ID/IQ construction phase  
5 contracts and statements of qualification for multiple award ID/IQ construction  
6 phase contracts received by the authority. The evaluation committee may be assisted  
7 by other authority personnel and external advisors in the evaluation of such proposals  
8 and statements of qualification.

9 (b) The evaluation committee shall evaluate such proposals and statements  
10 of qualification on the basis of the criteria identified in the RFP or RFQ which may  
11 include general and project specific criteria, such as:

12 (i) Experience of the contractor and of key personnel related to the project or  
13 type of work under consideration.

14 (ii) Past performane on authority projects.

15 (iii) Ability to obtain all bonding and insurance requirements.

16 (iv) Any project-specific criteria that may apply to project needs.

17 (c) The evaluation committee shall make a recommendation of award to the  
18 executive director. The authority shall make the final determination of award.

19 (d) The proposals and statements of qualification received by the authority  
20 and the evaluation committee's records, including the evaluations committee's  
21 findings, grading, score sheets, and recommendations, shall not be public records  
22 until the ID/IQ construction phase contract has been entered into or the procurement  
23 has been cancelled. The meetings of the evaluation committee shall not be subject  
24 to the Open Meetings Law.

25 (5) Prior to issuing a work order pursuant to a multiple award ID/IQ  
26 construction phase contract, the authority shall request, in writing, bids from the  
27 contractors awarded the contract. The authority shall issue the work order to the  
28 lowest responsive bidder."

42 (6) A statement of procedures and selection criteria the authority shall use in  
43 issuing work orders.

45 necessary to include in its procurement documents or contracts."
