Creates a "Spectrum Alert" system to assist in locating missing persons with autism spectrum disorder

Proposed law creates the Spectrum Alert system to alert the public when a child with Autism Spectrum Disorder (ASD) goes missing. Proposed law provides that the Department of Public Safety and Corrections (State Police) develop and implement an alert system, and develop training for law enforcement officers on responding to Spectrum Alerts. Proposed law provides for immunity from liability.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed law creates the Spectrum Alert System to alert the public when a child with ASD goes missing, including promulgating rules and regulations in accordance with the Administrative Procedures Act and developing training for law enforcement. Any expenditures incurred by DPS can be absorbed with existing resources. Additionally, LSP and the Office of Technology Services (OTS) collaborated to determine that LSP will be adding the spectrum alert to the existing RAVE alert system, which will not have any additional cost under the existing contract. Also, LSP has determined that the proposed law would not require any IT-related upgrades, modifications, and/or acquisitions; the current technology used for the AMBER and Silver Alert and Level II Endangered Missing Child Advisory will remain the same in the event this proposed law goes into effect.
