Amendments proposed by House Committee on Transportation, Highways and Public Works
to Original House Bill No. 896 by Representative Braud

1 AMENDMENT NO. 1

2 On page 1, at the end of line 8, insert "to provide for an effective date;"

3 AMENDMENT NO. 2

4 On page 2, line 5, after "assist" and before "drivers" insert a comma ", " and "in person,"

5 AMENDMENT NO. 3

6 On page 2, line 20, after "under" and before "in" delete "the exception as defined" and insert
7 "any exception provided"

8 AMENDMENT NO. 4

9 On page 2, line 25, after "the" and before "shall" delete "use of a toll project" and insert
10 "passage of a toll collection facility"

11 AMENDMENT NO. 5

12 On page 3, line 17, after "F." and before "The" insert "(1)"

13 AMENDMENT NO. 6

14 On page 3, between lines 19 and 20, insert the following:

15 "(2) No other tolls, fees, or other monetary impositions shall be collected by
16 the department or an authorized entity from a person's vehicle passage of a toll
17 facility unless expressly authorized by this Section.

18 (3) Any mailing costs assessed to the person charged for the toll shall not
19 exceed the actual cost of the postage."

20 AMENDMENT NO. 7

21 On page 3, line 27, after "within" and before "calendar" change "thirty" to "forty-five"

22 AMENDMENT NO. 8

23 On page 7, delete lines 5 and 6 in their entirety and insert the following:

24 "(b) Vehicles associated with law enforcement pursuant to R.S. 40:1392."

25 AMENDMENT NO. 9

26 On page 7, delete lines 12 through 15 in their entirety and insert the following:

28 "(f) Vehicles making one round-trip passage in a ninety day period traveling
29 through an unmanned toll collection facility. Notwithstanding the first round-trip,
30 vehicles that make more than one round-trip passage in a ninety day period shall be
31 charged for each passage."

1 AMENDMENT NO. 10

2 On page 7, line 16, after "The" delete the remainder of the line and insert "exceptions
3 contained in Paragraph (1) of this Subsection are limited to two"

4 AMENDMENT NO. 11

5 On page 7, line 17, after "vehicles" delete the remainder of the line and insert "owned and
6 registered by government employees."

7 AMENDMENT NO. 12

8 On page 7, at the beginning of line 18, delete "employees' name."

9 AMENDMENT NO. 13

10 On page 7, after line 19, insert the following:

11 "Section 2. This Act shall become effective upon signature by the governor
12 or, if not signed by the governor, upon expiration of the time for bills to become law
13 without signature by the governor, as provided by Article III, Section 18 of the
14 Constitution of Louisiana. If vetoed by the governor and subsequently approved by
15 the legislature, this Act shall become effective on the day following such approval."
