Amendments proposed by House Committee on Appropriations to Engrossed House Bill No. 1157 by Representative Bourriaque

1 AMENDMENT NO. 1

2 On page 1, line 8, after "Development, the" and before "Department" delete "Louisiana"

3 AMENDMENT NO. 2

4 On page 1, delete lines 10 through 12 in their entirety and insert the following:

5 "to establish the Louisiana State Infrastructure Fund as a special fund in the state
6 treasury and to provide for accounts within the fund; to provide for the transfer,
7 deposit, and use, as specified, of monies in the fund and accounts; to provide for the
8 powers and duties of the state treasurer;"

9 AMENDMENT NO. 3

10 On page 2, delete lines 18 through 29 in their entirety and insert the following:

11 "A. There is hereby established in the state treasury, as a special fund, the
12 Louisiana State Infrastructure Fund, hereafter referred to in this Section as the
13 "fund." The following accounts are hereby established in the fund:

14 (1)(a) A special account to be designated and referred to in this Section as the
15 Highway Account.

16 (b) After allocation of money to the Bond Security and Redemption Fund as
17 provided in Article VII, Section (9)(B) of the Constitution of Louisiana, the treasurer
18 shall deposit into the Highway Account the following:

19 (i) Monies transferred, appropriated, or dedicated to the Highway Account
20 by the legislature.

21 (ii) Federal funds as authorized by 23 U.S.C. 610.

22 (iii) Proceeds from federal credit instruments and programs, including those
23 administered by the United States Department of Transportation Build America
24 Bureau.

25 (iv) Interest earned on the investment of monies in the Highway Account, and
26 repayments of principal and interest from loans made by the Louisiana State
27 Infrastructure Bank from the Highway Account.

28 (v) Any gift, grant, or donation designated for the Highway Account and
29 received by the state treasurer."

38 shall deposit into the Transit Account the following:

39 (i) Monies transferred, appropriated, or dedicated to the Transit Account by
40 the legislature.

- 1 (ii) Federal funds as authorized by 23 U.S.C. 610.
- 2 (iii) Proceeds from federal credit instruments and programs, including those
- 3 administered by the United States Department of Transportation Build America
- 4 Bureau.
- 5 (iv) Interest earned on the investment of monies in the Transit Account, and
- 6 repayments of principal and interest from loans made by the Louisiana State
- 7 Infrastructure Bank from the Transit Account.
- 8 (v) Any gift, grant, or donation designated for the Transit Account and
- 9 received by the state treasurer."

- 22 (iii) Proceeds from federal credit instruments and programs, including those
- 23 administered by the United States Department of Transportation Build America
- 24 Bureau.
- 25 (iv) Interest earned on the investment of monies in the Rail Account, and
- 26 repayments of principal and interest from loans made by the Louisiana State
- 27 Infrastructure Bank from the Rail Account.
- 28 (v) Any gift, grant, or donation designated for the Rail Account and received
- 29 by the state treasurer."

- 42 and repayments of principal and interest from loans made by the Louisiana State
- 43 Infrastructure Bank from the State-Funded Account.
- 44 (iii) Any gift, grant, or donation designated for the State-Funded Account and
- 45 received by the state treasurer.
- 46 (c) No funds authorized by Title 23 or Title 49 of the United States Code
- 47 shall be deposited into the State-Funded Account."
