8 (c) Does not permit account creation by individuals under eighteen years of
9 age.
10 (d) Verifies that the primary account holder is an adult using commercially
11 available methods that are reasonably designed to ensure accuracy."

27 application.

28 (b) Permit the primary account holder to attest to the age categories of
29 associated subaccounts.

30 (2) A developer of a family account application remains subject to all other
31 requirements of this Section."
