2 On page 1, delete line 2 in its entirety and insert in lieu thereof the following:  
3 "To amend and reenact R.S. 22:1868(B)(introductory paragraph), (1),(2), and (4), and  
4 (C), to"

5 AMENDMENT NO. 2

6 On page 1, line 3, after "(E)," and before "relative" insert "and 1868.2, and to repeal R.S.  
7 22:1868(B)(2) and (C)(2),"

8 AMENDMENT NO. 3

9 On page 1, line 5, after "prohibitions;" and before "and" insert the following:  
10 "to provide for an effective date; to provide for retroactive application; to provide for  
11 authorization of copayment assistance benefits;"

12 AMENDMENT NO. 4

13 On page 1, delete line 8 in its entirety and insert in lieu thereof the following:  
14 "Section 1. R.S. 22:1868(B)(introductory paragraph), (1),(2), and (4), and (C) are  
15 hereby"

16 AMENDMENT NO. 5

17 On page 1, line 9, after "(E)" and before "are" insert "and 1868.2"

18 AMENDMENT NO. 6

19 On page 2, delete lines 9 through 12 in their entirety

20 AMENDMENT NO. 7

22 "(4) "Reimbursement formula" means a prescription drug reimbursement calculation  
23 involving an ingredient price, calculated based on a prescription drug pricing benchmark  
24 plus ~~an adjustment factor, and~~ a professional dispensing fee."

5 "D. A pharmacy benefit manager in this state bears all costs associated with"

6 AMENDMENT NO. 12

7 On page 5, line 9, after "adjustments" delete the comma " , "

8 AMENDMENT NO. 13

9 On page 5, between lines 10 and 11, insert the following:

10 "§1868.2. Authorization of copay assistance benefit plans

11 A health insurance issuer or pharmacy benefit manager may implement copayment  
12 assistance benefit plans, also known as copay maximizer plans, for its members or  
13 enrollees as permitted by federal law. Participation by a member or enrollee  
14 is optional.

15 Section 2. R.S. 22:1868(B)(2) and (C)(2) are hereby repealed in their entirety.

16 Section 3. The provisions of this Act shall be given prospective and retroactive  
17 application. The reimbursement formula created in this Act shall be adopted retroactively  
18 to January 1, 2026."
