2 retirement system. The municipality shall provide annual proof of death and
3 disability coverage to the Municipal Police Employees' Retirement System board of
4 trustees. A municipality that elects to terminate participation pursuant to this
5 Subsection and does not enroll its police officers in the Death and Disability Subplan
6 shall be deemed to have fully dissolved its police department in accordance with R.S.
7 11:2225.4."
