1 AMENDMENT NO. 12 On page 1, at the beginning of line 3, insert "Louisiana and to add Article VII, Section 10.18
3 of the Constitution of"4 AMENDMENT NO. 25 On page 1, delete line 4 in its entirety and insert "use of certain funds may be restricted to

15 On page 3, delete lines 3 through 9 in their entirety and insert the following:

16 "(b) Except as otherwise provided in this Constitution, the legislature shall
17 not appropriate or transfer any recurring revenue amounts recognized in the official
18 forecast for the State General Fund (Direct) means of finance that are above the
19 Government Growth Limit and below the expenditure limit. If the legislature
20 changes the Government Growth Limit for a fiscal year, provides an exception to the
21 Government Growth Limit as provided in Subsubparagraph (c) of this Subparagraph,
22 or both, then the legislature shall not cause the aggregate amount of all appropriated
23 and all transferred recurring State General Fund (Direct) revenues above the
24 applicable Government Growth Limit to exceed the aggregate amount of all such
25 changes for that same fiscal year."26 AMENDMENT NO. 627 On page 3, line 14, after "factors for" and before "fiscal years" delete "any of the three" and

1 AMENDMENT NO. 9

2 On page 4, between lines 13 and 14 insert the following:

3 "10.18. Louisiana Income Tax Elimination Fund4 Section 10.18. (A) There is hereby established in the state treasury the
5 Louisiana Income Tax Elimination Fund, hereafter referred to in this Section as the
6 "fund".7 (B) After allocation of money to the Bond Security and Redemption Fund
8 as provided in Article VII, Section 9(B) of this Constitution, the treasurer shall
9 annually deposit in and credit to the fund all recurring state general fund revenues
10 received by the state in excess of the Government Growth Limit and below the
11 official forecast for that fiscal year.12 (C) Monies in the fund shall be invested in the same manner as monies in the
13 state general fund. All interest earned from the investment of monies in the fund
14 shall be deposited in and credited to the fund. All unexpended and unencumbered
15 monies in the fund at the end of the fiscal year shall remain in the fund.16 (D) Monies in the fund shall be appropriated only for the following:17 (1) For the same purposes and under the same conditions as appropriation
18 of monies in the Budget Stabilization Fund.19 (2) For the retiring or defeasance of bonds in advance or in addition to the
20 existing amortization requirements of the state.21 (3) For payments against the unfunded accrued liability of one or more state
22 retirement systems which are in addition to any payments required for the annual
23 amortization of the unfunded accrued liability of the system; however, any such
24 payments shall not be used, directly or indirectly, to fund any benefit increase for
25 such system.26 (4) For costs associated with actual project delivery, construction, and
27 maintenance of transportation and capital transit infrastructure projects of the state

31 AMENDMENT NO. 11

32 On page 4, delete lines 19 and 20 in their entirety and insert the following:

33 "any of the following:

34 (1) Any appropriation or allocation excluded from analysis of appropriation and transfer
35 totals in relation to the expenditure limit.36 (2) Any funds appropriated as a result of a means of financing substitution resulting in
37 an increase in the State General Fund (Direct) means of finance to compensate for
38 a decrease in federal funding, funds transferred from another state entity, self-
39 generated collections, or statutorily or constitutionally dedicated funds.
