DISTRICT ATTORNEYS/ASST: Provides relative to the number of assistant district attorneys in each judicial district

1 AN ACT

2 To amend and reenact R.S. 16:51(A)(1), (3) through (7), (9), (13) through (17), (19) through  
3 (25), (27), (30) through (33), (35) through (37), and (39) through (42), relative to  
4 assistant district attorneys; to provide for the number of assistant district attorneys  
5 in each judicial district; to provide for an effective date; and to provide for related  
6 matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 16:51(A)(1), (3) through (7), (9), (13) through (17), (19) through  
9 (25), (27), (30) through (33), (35) through (37), and (39) through (42) are hereby amended  
10 and reenacted to read as follows:

11 §51. Assistant district attorneys

12 A. The district attorney of each judicial district and of the parish of Orleans  
13 shall appoint a first assistant district attorney and such other assistant district  
14 attorneys for his respective judicial district or for the parish of Orleans as may be  
15 necessary, the total number of assistant district attorneys in each judicial district and  
16 in the parish of Orleans to be not less than the following:

1 2027, if the Governor's Advisory and Review Commission on Assistant District Attorneys  
2 provides a recommendation that such additional assistant district attorneys meet the  
3 applicable guidelines in its report to the governor and the Louisiana Legislature. No  
4 additional assistant district attorneys shall be appointed without commission approval.

Present law provides for the number of assistant district attorneys in the judicial districts of the state of La.

Proposed law increases the number of assistant district attorneys in the First Judicial District from 35 to 40.

Proposed law increases the number of assistant district attorneys in the Third Judicial District from nine to 10.

Proposed law increases the number of assistant district attorneys in the Fourth Judicial District from 26 to 28.

Proposed law increases the number of assistant district attorneys in the Fifth Judicial District from seven to eight.

Proposed law increases the number of assistant district attorneys in the Sixth Judicial District from seven to eight.

Proposed law increases the number of assistant district attorneys in the Seventh Judicial District from six to seven.

Proposed law increases the number of assistant district attorneys in the Ninth Judicial District from 15 to 17.

Proposed law increases the number of assistant district attorneys in the Thirteenth Judicial District from five to six.

Proposed law increases the number of assistant district attorneys in the Fourteenth Judicial District from 25 to 26.
