EMPLOYMENT OF MINORS EN NO IMPACT See Note
Provides relative to employment certificates for minors

Present law provides that employment certificates may be issued by either: 1) the parish or city public school superintendent or his designated representative or 2) the principal of a public or private school or his designated representative. The proposed law repeals present law.

Proposed law requires the secretary of Louisiana (LA) Works to prescribe and furnish employment certificate forms on the department's website or at its local field offices. The form must include: 1) a signature line for the minor seeking employment, 2) a date line indicating when the minor signs the certificate, 3) a statement and signature line for the parent or legal guardian to provide and affirm consent of the minor being employed, 4) a date line indicating when the parent/legal guardian signs the certificate, 5) a statement explaining the submission of proofs of age, and 6) a line for the minor to provide the name of prospective employer.
