Provides for anatomical gift authorization on driver's license. (1/1/27)

Proposed law allows individuals to indicate anatomical gift authorization on a driver's license or state identification card. Proposed law provides that a person may authorize the donation of organs, tissues, or other anatomical gifts upon death through the licensing process, rather than requiring a separate form or signature. Proposed law shall be known and may be cited as the "Driver's License Anatomical Gift Consent Clarity Act." Proposed law provides for an effective date of June 1, 2027.

**EXPENDITURE EXPLANATION**

Proposed law may result in an increase in expenditures for the Office of Motor Vehicles (OMV) related to implementing anatomical gift authorization on driver's licenses and state identification cards. OMV indicates that a professional services contract with the driver's license credentialing vendor will be required. The Office of Technology Services (OTS) has provided an estimated one-time cost of at least \$200,000 due to the need for multiple driver's license system modifications. OMV further indicates that this contract will be required even if implementation occurs after the CHAMP (Drive 360) system is deployed in FY 2028.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
