INDIGENT DEFENSE

Provides relative to the office of the state public defender

Current law provides for the Office of the State Public Defender (OSPD); requires the public defender board to be appointed by the governor, subject to approval by a majority of the Louisiana Public Defender Oversight Board (LPDOB) and Senate Confirmation, for a term of two years; provides for the setting of compensation for each district defender, the continuation of the salaries and benefits in place on 1/01/07 for each chief defender, as well as a prohibition on salary decreases; requires all appointments by a district defender to deliver public defender services in each district on a successive, rotational basis by case-type certification; provides for dispositions of fines and forfeitures; requires the prosecuting attorney to pay 25% of funds collected to the Indigent Defenders Program of the court where judgment was rendered. Proposed law changes reference of the "Louisiana Public Defender Board" and "indigent defender program" to "Office of the State Public Defender" and "district public defender"; removes the condition that the state public defender's appointment be subject to approval by a majority of the LPDOB; repeals current law and provides that a district defender who contracts with the OSPD for delivery of legal services is an independent contractor and not an office employee; requires deviation from the board's list to be permitted only to comply with current law and in exceptional circumstances upon approval of the office on the district defender's recommendation.
