 9 assessment review report and shall post the report on the same website as the
 10 schedule required by Subparagraph (d) of this Paragraph no later than November first
 11 of each school year.

12 (ii) The annual local assessment review report shall address, for each locally
 13 adopted or required benchmark, interim assessment, screener, progress-monitoring
 14 assessment, and other locally required assessment listed on the schedule required by
 15 Subparagraph (d) of this Paragraph, all of the following:

16 (aa) The time required to administer the assessment.

17 (bb) The purpose of the assessment.

18 (cc) The intended use of the results.

19 (dd) The timeliness of results.

20 (ee) Whether the assessment duplicates another assessment.

21 (ff) Whether the assessment was retained, reduced, consolidated, replaced,
 22 or eliminated as a result of the annual review.

23 (iii) The report required by this Subparagraph shall be submitted to the
 24 department in the form and manner prescribed by the department.

25 (i) Beginning in the 2026-2027 school year and for each school year
 26 thereafter, the department shall annually publish on its website a consolidated
 27 inventory of assessments and screeners required by federal law, state law, and rules
 28 of the state board. The inventory shall not include personally identifiable student
 29 information or student-level assessment results."
