17 **owner for a mega project, submit a copy of that contract, and a tentative listing**  
18 **of subcontractors or subcontractor opportunities anticipated to be used on the**  
19 **mega project.**

20 **(2) Annually submit a detailed listing of subcontractors engaged to work**  
21 **on the mega project, including licensure information or evidence of approval by**  
22 **the secretary of state as a foreign entity registered to do business in this state."**
