2 On page 1, line 2, after "through" delete the remainder of the line and insert "(D) and R.S.

4 AMENDMENT NO. 2

5 On page 3, delete lines 7 and 8 and insert the following:

6 "(3) The president of the Louisiana State Board of Nursing or his designee."

7 AMENDMENT NO. 3

8 On page 3, delete lines 11 through 26 and insert the following:

31 On page 12, line 7, after "notification." delete the remainder of the line and delete line 8

2 On page 13, line 25, after "services" delete the remainder of the line and insert "provided for  
3 in R.S. 15:622(2) and"

4 AMENDMENT NO. 7

5 On page 14, between lines 2 and 3, insert the following:

6 "(3) Any testing related to the sexual assault or recommended by the  
7 healthcare provider.

8 (4) Any medication provided during the forensic medical examination.

9 B. The healthcare provider who conducted the forensic medical examination  
10 and the hospital or healthcare facility where the forensic medical examination was  
11 conducted shall submit a claim for reimbursement directly to the Crime Victims'  
12 Compensation Board, to be paid in accordance with the provisions of R.S. 46:1822."

25 regarding statewide standards for kit collection, documentation, storage, transfer, and  
26 processing in order to ensure uniform policies and procedures across all participating  
27 agencies and regions."
