- 2 **experts in unmanned aircraft systems.**
- 3 **(c) The Adjutant General of Louisiana, or his designee.**
- 4 **(d) An employee of the Governor's Office of Homeland Security and**
- 5 **Emergency Preparedness who is a subject matter expert in unmanned aircraft**
- 6 **systems.**
- 7 **(e) The executive director of the Louisiana Sheriffs' Association, or his**
- 8 **designee.**
- 9 **(f) Two members of the Louisiana Sheriffs' Association, appointed by the**
- 10 **association's executive committee, who are each subject matter experts in unmanned**
- 11 **aircraft systems.**
- 12 **(g) The president of the Louisiana Association of Chiefs of Police, or his**
- 13 **designee.**
- 14 **(h) One member of the Louisiana Association of Chiefs of Police who is**
- 15 **selected by the executive officers of the association and who is a subject matter**
- 16 **expert in unmanned aircraft systems.**
- 17 **(3) Members shall serve without compensation, except for per diem or**
- 18 **expenses to which they may be entitled as members of their constituent**
- 19 **organizations.**
- 20 **(4) A majority of the total membership shall constitution a quorum of the**
- 21 **task force and any official action taken by the task force shall require an affirmative**
- 22 **vote of the majority of the quorum present and voting.**
- 23 **(5) The office of state police shall provide staff support to the task force.**
- 24 **(6) The task force may create subcommittees as it deems necessary."**

3 "K. The provisions of this Section shall be null and void and terminate on
4 June 30, 2028."
