16 "(1) "Abandoned property" means property that is vacant or not lawfully
17 occupied. The term "vacant or not lawfully occupied" includes but is not limited to
18 any premises which are not actually occupied by its owner, lessee, or other invitee
19 or if occupied, without utilities, and has been left unsecured or inadequately secured
20 from unauthorized entry to the extent that the premises could be entered and utilized
21 by vagrants or other uninvited persons as a place of harborage or any premises which
22 by reason of dilapidation, deterioration, state of disrepair, or other such status is
23 otherwise detrimental to or endangers the public safety, health, or welfare.

24 (2) "Blighted property" means any commercial or residential premises,
25 including a vacant lot, which has been declared vacant, uninhabitable, or hazardous
26 by an administrative hearing officer acting pursuant to R.S. 13:2575 and 2576, or any
27 other applicable law."
