1 AN ACT

2 To provide relative to state highways; to designate a portion of Louisiana Highway 526 in
3 Caddo Parish as "Hayden Lane Mangum Memorial Highway"; to provide for
4 location and placement of signage; to provide for restrictions on costs of materials
5 to the department; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 **Section 1. Notwithstanding any other provision of law to the contrary, Louisiana**
8 **Highway 526, also known as East Bert Kouns Industrial Drive, beginning at Wrenwood**
9 **Boulevard and ending on the western side of the Interstate 49 Interchange at Premier**
10 **Court, all of which is situated in Shreveport, Louisiana, in Caddo Parish, is hereby**
11 **designated as "Hayden Lane Mangum Memorial Highway".**

12 **Section 2. The Department of Transportation and Development is hereby**
13 **directed to erect and maintain appropriate signs of this designation provided local or**

1 private monies are received by the department equal to the department's actual costs
2 for material, fabrication, mounting posts, and installation of each sign, not to exceed
3 the sum of seven hundred fifty dollars per sign.
