EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed law amends R.S. 49:1302(D) and R.S. 43:82(5) to require that Louisiana boards and commissions websites display each member's private email address, or an email address accessible through the board or commission, and a direct phone number. Division of Administration (DOA), Office of Technology Services (OTS), indicates that the website database can accommodate the new fields using existing resources. Each board or commission will be responsible for updating and maintaining the information.
