1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" insert "R.S. 15:587.1.2(A)(2)(a)(i) and" and after "(E)(1),"  
3 delete "and"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "(D)(1)," insert "and 2008.10(A)(1)(a)(i),"

6 AMENDMENT NO. 3

7 On page 1, between lines 10 and 11, insert the following:

8 "Section 1. R.S. 15:587.1.2(A)(2)(a)(i) is hereby amended and reenacted to read as  
9 follows:

10 §587.1.2. Provision of information to protect children who receive services at a  
11 therapeutic group home

12 A.(1) As provided in R.S. 40:2008.10, the Louisiana Department of Health  
13 shall request in writing that the bureau supply information to ascertain whether the  
14 persons listed in Paragraph (2) of this Subsection have been arrested for or convicted  
15 of, or pled nolo contendere to, any criminal offense. The request shall be on a form  
16 prepared by the bureau and signed by a responsible official of the Louisiana  
17 Department of Health making the request. The request shall include a statement  
18 signed by the person about whom the request is made which gives his permission for  
19 such information to be released.

20 (2)(a) The persons to which this Section applies include:

21 (i) Any person who owns, operates, or manages a licensed therapeutic group  
22 home individual who has any ownership interest in a therapeutic group home or who  
23 has managerial authority over its business operations or its provision of client care.

36 A.(1)(a) The provisions of this Section shall apply to the following persons:

37 (i) Any person who owns, operates, or manages a licensed therapeutic group  
38 home individual who has any ownership interest in a therapeutic group home or who  
39 has managerial authority over its business operations or its provision of client care.
