Amendments proposed by Senate Committee on Education to Reengrossed House Bill No. 352 by Representative Mack

1 AMENDMENT NO. 1

2 On page 3, between lines 5 and 6, insert the following:

3 "(l)(i) The contract or agreement between a public school governing authority  
4 and a behavioral health provider may specify whether a school principal may dismiss  
5 a behavioral health provider staff member from the campus and the terms under  
6 which such a dismissal is permissible."

7 AMENDMENT NO. 2

8 On page 3, at the beginning of line 6, change "l(i)" to "(ii)"

9 AMENDMENT NO. 3

10 On page 3, at the beginning of line 16, change "(ii)" to "(iii)"

11 AMENDMENT NO. 4

12 On page 3, at the beginning of line 23, change "(iii)" to "(iv)"

13 AMENDMENT NO. 5

14 On page 4, line 15, after "plan." insert the following:

15 "The school-based service delivery meeting shall not take the place of any meetings  
16 required by a student's Individualized Education Plan."

17 AMENDMENT NO. 6

18 On page 4, at the beginning of line 16, change "(iv)" to "(v)"

19 AMENDMENT NO. 7

20 On page 4, at the beginning of line 19, change "(v)" to "(vi)"

21 AMENDMENT NO. 8

22 On page 4, at the beginning of line 24, change "(vi)" to "(vii)"

23 AMENDMENT NO. 9

24 On page 4, at the beginning of line 26, change "(vii)" to "(viii)"

25 AMENDMENT NO. 10

26 On page 5, at the beginning of line 1, change "(viii)" to "(ix)"

27 AMENDMENT NO. 11

28 On page 5, delete line 3, and insert the following:

29 "or conflict with services the school is legally required to provide under a student's  
30 Individualized Education Plan, Individualized Accommodation Plan, Section 504

1 Plan, Behavior Intervention Plan, or Individualized Health Plan, without  
2 collaboration and agreement"

3 AMENDMENT NO. 12

4 On page 5, line 21, after "occurred." insert the following:

5 "In the event of a conflict between a student's Individualized Education Plan,  
6 Individualized Accommodation Plan, Section 504 Plan, Behavior Intervention Plan,  
7 or Individualized Health Plan and a behavioral health provider's written treatment  
8 plan, the applicable student plan shall control with respect to the educational services  
9 and supports addressed by that plan. Nothing in this Section shall be construed to  
10 require medically necessary behavioral health services authorized under this Section  
11 be included in any such student plan as a condition of being delivered on school  
12 property, nor shall the absence of such services from any such student plan constitute  
13 a basis to deny those services."
