1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 22:1892(A)(1)" delete the remainder of the line and insert the
3 following:

4 "and (I)(2)(a) and (3) and to enact R.S. 22:1892(I)(4) and (L), relative to the"

5 AMENDMENT NO. 2

6 On page 1, line 5, after "contractor verification;" insert the following:

7 "to provide for breach of good faith duty; to provide for limitations on causes of action;"

8 AMENDMENT NO. 3

9 On page 1, line 8, after "R.S. 22:1892(A)(1)" delete the remainder of the line and insert the
10 following:

11 "and (I)(2)(a) and (3) are hereby amended and reenacted and R.S. 22:1892(I)(4) and (L) are"

12 AMENDMENT NO. 4

13 On page 1, line 9, delete "is"

14 AMENDMENT NO. 5

15 On page 2, between lines 7 and 8, insert the following:

16 "I.(1) * * *

18 (2) Any one of the following acts, if knowingly committed or performed by an
19 insurer or representative of the insurer, constitutes a breach of the insurer's duties imposed
20 in Paragraph (1) of this Subsection:

21 (a) A misrepresentation of pertinent facts or insurance policy provisions relating to
22 any coverages at issue or a misrepresentation of relevant insurance policy provisions.

23 * * *

24 (3) The provisions of this Subsection shall not create a cause of action against an
25 insurer by the insured or his assignee in a claim for personal injury or bodily injury when
26 any of the following conditions are present:

27 (a) There is a good faith dispute as to liability.

28 (b) There is a good faith dispute as to medical causation for the injuries alleged by
29 the claimant.

30 (c) An offer has not been presented by or on behalf of a third-party claimant within
31 the applicable policy limits, and the insurer has been given at least thirty days to respond.

33 (4) The provisions of this Subsection shall not create a separate cause of action
34 against a representative of the insurer distinct and apart from the cause of action against the
35 insurer.
