



1           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
2 direct the Louisiana State Board of Medical Examiners to conduct, or cause to be conducted,  
3 a two-year study of the feasibility and advisability of establishing a physician review panel  
4 process for certain complaints against physicians prior to escalation to formal disciplinary  
5 proceedings.

6           BE IT FURTHER RESOLVED that the study shall examine all of the following  
7 issues:

8           (1) Whether complaints involving clinical decision making, diagnosis, treatment,  
9 prescribing, supervision of clinical care, documentation of care, or standard of care should  
10 be eligible for physician review panel consideration, and whether complaints primarily  
11 involving billing disputes, fee disputes, other financial complaints, or allegations of sexual  
12 misconduct should be excluded.

13           (2) Whether physician review panel consideration should be mandatory or optional  
14 at the election of the physician who is the subject of the complaint.

15           (3) Whether the time limitation provided in R.S. 37:1285.2(A)(2) should be tolled  
16 during physician review panel consideration.

17           (4) Appropriate qualifications for panel members, including active clinical practice  
18 requirements, board certification in a specialty recognized by the American Board of  
19 Medical Specialties when reasonably available, use of physicians in the same specialty or  
20 a substantially similar field of practice, and use of non-board-certified physicians when  
21 board certification is unavailable and the physician has substantial experience in the area of  
22 practice under review.

23           (5) Appropriate procedures for empaneling physician review panels, including  
24 deadlines for designation of members, methods of resolving deadlocks in the selection of a  
25 third member, and procedures for filling vacancies or resolving recusals and  
26 disqualifications.

27           (6) The proper role and legal effect of a physician review panel recommendation,  
28 including whether such a recommendation should be advisory only or entitled to greater  
29 weight in the disciplinary process.

1 (7) Appropriate confidentiality protections for records, notes, data, studies, analyses,  
2 exhibits, written recommendations, findings, determinations, and proceedings of the  
3 physician review panel, including whether protections similar to those found in R.S.  
4 13:3715.3 should apply.

5 (8) Appropriate compensation for panel members and the advisability of imposing  
6 a fee on a physician who elects physician review panel consideration, including whether any  
7 such fee should be capped.

8 (9) The effect such a process would have on administrative efficiency, physician  
9 participation, due process, protection of the public, and the timely resolution of complaints.

10 BE IT FURTHER RESOLVED that, in conducting the study, the LSBME shall  
11 consult with representatives of the Louisiana State Medical Society, physicians from a  
12 variety of specialties, and such other stakeholders as the board deems appropriate.

13 BE IT FURTHER RESOLVED that the LSBME shall submit an initial progress  
14 report on the study not later than December 1, 2027, and shall submit a final written report  
15 of its findings, conclusions, and recommendations not later than February 1, 2028, to the  
16 House Committee on Health and Welfare and the Senate Committee on Health and Welfare.

17 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the  
18 executive director of the Louisiana State Board of Medical Examiners and to the president  
19 of the Louisiana State Medical Society.
