 Provides for requirements for commissioners of the Caddo-Bossier Parishes Port Commission. (8/1/26)

Purpose of Bill: This bill amends the requirements for members of the Caddo-Bossier Parishes Port Commission to require all appointed commissioners be subject to Senate confirmation and that members possess expertise in economic development, transportation, logistics, or commercial real estate. It further provides that commissioners appointed by the parish of Bossier (1), the city of Shreveport (4), and the city of Bossier City (2) may serve a maximum of two consecutive terms.
