35 §259. Department of Justice Legal Support Fund
36 A. * * *

37 B.(1) After satisfying the requirements of the Bond Security and Redemption
38 Fund as provided in Article VII, Section 9(B) of the Constitution of Louisiana, the
39 treasurer shall transfer into the fund each fiscal year from proceeds received as
40 provided in Subsection A of this Section an amount which together with the balance
41 in the fund as of each July first is sufficient to bring the balance in the fund to ~~fifteen~~
42 twenty million dollars annually. Annual deposits into the fund shall not exceed a
43 total of ~~fifteen~~ twenty million dollars, and the balance of the fund shall not exceed
44 ~~fifteen~~ twenty million dollars. Any proceeds received as provided in Subsection A
45 of this Section, after making the total annual deposit into the fund of ~~fifteen~~ twenty
46 million dollars, shall be deposited into the state general fund.
