HOUSING REF +\$40,000 SG RV See Note Page 1 of 1  
 Provides relative to the regulation of manufactured housing. (8/1/26)

Proposed law amends statutes governing the regulation of manufactured housing in Louisiana, including definitions relating to homes, initial purchasers, major structural defects, manufactured homes, modular homes, and owners. Proposed law clarifies and updates regulatory terminology and standards applicable to factory-built residential dwelling units. Proposed law repeals of the existing Louisiana Manufactured Housing Commission and the reassignment of its powers and duties to the Residential Subcommittee of the State Licensing Board for Contractors (LSLBC). Proposed law allows local governments to charge a reasonable inspection fee and permits licensees to hire a certified third-party provider to conduct installation inspections. Proposed law provides effective date of August 1, 2026.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.


**REVENUE EXPLANATION**

Proposed law may result in an increase in SGR of approximately \$40,000 annually for the LSLBC. The proposed law does not expressly establish new statewide fee amounts or modify existing statutory fee schedules. However, it results in structural changes to fee collection and authority, including the reassignment of existing fees from the Louisiana Manufactured Housing Commission to the LSLBC. This reassignment creates a new classification for contractors to be licensed under the board. The LSLBC anticipates collections from license renewals of approximately 400 licensees in FY27. With a renewal fee of \$100 per licensee, the total projected annual collection will be \$40,000 (400 licensees x \$100= \$40,000). Any additional revenue generated from penalties, fees, or increased compliance is indeterminate at this time.

Additionally, proposed law authorizes local governments to assess reasonable inspection fees, which may result in new or increased fees at the local level.
