 Requires public postsecondary education institutions to post information on campuses promoting STI prevention, screening, and treatment to be known as the Campus Awareness Initiative. (gov sig)
 Proposed legislation provides that LDH, or its designated nonprofit organization, produce and distribute signs for student health centers at public postsecondary education institutions. Proposed law requires the signs to read "Worried about STIs? Just Check!" Provides that signs include a website link to information and resources on STI prevention, screening, and treatment listed on the LDH website. Provides that signs be at least 16 inches by 20 inches with a large, easily readable font. Proposed law defines "designated nonprofit organization" as a private tax-exempt nonprofit designated by the Secretary of LDH to assist in carrying out the provisions of proposed legislation.

EXPENDITURE EXPLANATION

Proposed legislation does not require the Louisiana Department of Health (LDH) to spend state funds to purchase signage or the Campus Awareness Initiative; rather, LDH may spend donated funds or accept donated signs, provided the signs are approved by the department. Any signage designed and produced by LDH or its designated nonprofit organization is anticipated to be funded through donations.

REVENUE EXPLANATION

Proposed legislation authorizes LDH to receive donations, which may offset expenditures associated with the Campus Awareness Initiative. The amount of revenue that would be received from donations is speculative and indeterminable.
