SENATE RESOLUTION NO. 187

BY SENATOR CARTER

LAW ENFORCEMENT. Requests the LCLE to report to the Senate Committee on Judiciary B on the progress of the implementation of Act 426 of the 2025 Regular Session.

1 A RESOLUTION

2 To urge and request the Louisiana Commission on Law Enforcement and the Administration
3 of Criminal Justice (LCLE) to report to the Senate Committee on Judiciary B on the
4 progress of the implementation of Act 426 of the 2025 Regular Session.

5 WHEREAS, the Louisiana Commission on Law Enforcement and the Administration
6 of Criminal Justice is charged with supporting, coordinating, and enhancing the effectiveness
7 of the state's criminal justice system; and

8 WHEREAS, Act 426 of the 2025 Regular Session established important requirements
9 that the P.O.S.T. Council adopt a policy regarding mandatory reporting when a peace officer
10 uses force, under certain circumstances; and

11 WHEREAS, the successful implementation of Act 426 is essential to achieving the
12 Legislature's goals of improving public safety, enhancing accountability, and ensuring
13 consistent standards across law enforcement agencies; and

14 WHEREAS, ongoing legislative oversight is necessary to monitor progress, identify
15 challenges, and ensure that the provisions of Act 426 are being carried out as intended; and

16 WHEREAS, the Senate Committee on Judiciary B is the appropriate body to receive
17 updates and evaluate the status of implementation efforts.

18 THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana

1 does hereby urge and request the Louisiana Commission on Law Enforcement and the
2 Administration of Criminal Justice to report to the Senate Committee on Judiciary B on the
3 progress of the implementation of Act 426 of the 2025 Regular Session.

4 BE IT FURTHER RESOLVED that the report shall include, at minimum:

- 5 (1) A summary of actions taken to implement Act 426 to date.
- 6 (2) Identification of challenges or barriers encountered during implementation.
- 7 (3) A timeline of remaining tasks necessary to achieve full compliance.
- 8 (4) Recommendations for any legislative or administrative changes needed to support
9 successful implementation.

10 BE IT FURTHER RESOLVED that LCLE shall submit its report to the Senate
11 Committee on Judiciary B no later than September 1, 2026.

12 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
13 chairman of the Louisiana Commission on Law Enforcement and the Administration of
14 Criminal Justice.
