Provides relative to material harmful to minors

Proposed law provides that an interactive computer service that contains material harmful to minors and enters into a contract with a minor, including the creation of an online account, shall not deliver or display to a minor account material harmful to minors created or developed, in whole or in part, by the interactive computer service; provides that any interactive computer service in violation is subject to a \$10,000 civil fine per violation enforceable by the Attorney General (AG) filing a civil enforcement action, for failing to cure a violation or committing another violation after receiving written notice; provides that prior to filing an enforcement action, the AG shall provide the interactive computer service with a written notice that identifies each alleged violation and an explanation of the basis for each allegation; provides that the interactive computer service may cure the alleged violation by providing the AG with a written statement, within 45 days of receipt of notice, indicating that the violation is cured and no further violations will occur; provides that the AG shall not file an enforcement action if the interactive computer service timely cures the alleged violations; provides that if a court grants judgment or injunctive relief to the AG, the court shall award reasonable attorney's fees, court costs, and investigative costs; provides that monetary fines or civil penalties imposed shall be used by the AG for consumer protection efforts or to promote consumer protection and education.

EXPENDITURE EXPLANATION

Proposed law may result in an indeterminable increase in workload in the Office of the Attorney General, to the extent that the office pursues civil actions to recover fines against interactive computer services that contain material harmful to minors that deliver or display to a minor account material harmful to minors created or developed, in whole or in part, by the interactive computer service. The exact fiscal impact to the Attorney General is indeterminable, because it is unknown the number of instances in which the Attorney General will pursue these civil enforcement actions and participate in hearings on these matters. Any fiscal impact is projected to be absorbed within the Attorney General's budget.

REVENUE EXPLANATION

Proposed law may result in an indeterminable increase in Self-Generated Revenue in the Office of the Attorney General to the extent that the office recovers fines (up to \$10,000) from interactive computer services in violation of the proposed law, or those who fail to cure or commit additional violations after being provided notice by the Attorney General. The exact impact to Self-Generated Revenue is indeterminable, as it is unknown the number of civil enforcement actions brought by the Attorney General that will yield civil fines against those determined liable under the proposed law. Proposed law requires all monies received from the payment of fines or civil penalties imposed to be used by the Attorney General for consumer protection efforts or to promote consumer protection and education.
