1 AN ACT

2 To amend and reenact Chapter 13 of the of Title 6 of the Louisiana Revised Statutes of  
3 1950, to be comprised of R.S. 6:1031 through 1072, relative to the Louisiana Money  
4 Transmission Act; to provide for a short title; to provide for a purpose; to provide for  
5 definitions; to provide for exemptions under certain circumstances; to require  
6 information and documentation in order to qualify for an exemption; to provide for  
7 the duties of the commissioner and the office of financial institutions; to provide for  
8 the use of the Nationwide Multistate Licensing System; to provide for licensing fees;  
9 to provide for record keeping; to provide for applications for and the issuance,  
10 renewal, and maintenance of licenses; to provide for implementation and rule  
11 promulgation; to provide for consistent licensing between states; to provide for  
12 notice and information requirements for changing key individuals; to require  
13 reporting; to require auditing of finances; to provide for certain unauthorized and  
14 prohibited activities; to provide for bond requirements; to provide for permissible  
15 investments; to provide for suspension and revocation of licenses under certain  
16 circumstances; to provide for license and notice revocation hearings; to provide for  
17 penalties; and to provide for related matters.

18 Be it enacted by the Legislature of Louisiana:

19 Section 1. Section 2 of this Act amends and reenacts Chapter 13 of Title 6 of the  
20 Louisiana Revised Statutes of 1950 in its entirety. Due to the length of the Chapter, present  
21 law is not included as overstruck text.

1           Section 2. Chapter 13 of Title 6 of the Louisiana Revised Statutes of 1950,  
2           comprised of R.S. 6:1031 through 1072, is hereby amended and reenacted to read as follows:

3                           CHAPTER 13: THE LOUISIANA MONEY TRANSMISSION ACT

4           §1031. Short title

5                           This Chapter shall be known as and may be cited as the "Louisiana Money  
6                           Transmission Act."

7           §1032. Purpose

8                           This Chapter is designed to replace the "Sale of Checks and Money  
9                           Transmission Act" codified at Title 6, Chapter 13, R.S. 6:1031 et seq. It is the intent  
10                          of the Legislature that the provisions of this Chapter accomplish all of the following:

11                          (1) Ensure states can coordinate in all areas of regulation, licensing, and  
12                          supervision to eliminate unnecessary regulatory burden and more effectively utilize  
13                          regulatory resources.

14                          (2) Protect the Louisiana public from financial crime.

15                          (3) Standardize the types of activities that are subject to licensing or  
16                          otherwise exempt from licensing.

17                          (4) Modernize the licensure, supervision, and regulation of multistate money  
18                          transmission licenses with current safety and soundness requirements to ensure  
19                          customer funds are protected in an environment that supports innovative and  
20                          competitive business practices.

21           §1033. Definitions

22                           For purposes of this Chapter, the following definitions have the following  
23                           meanings:

24                          (1) "Acting in concert" means persons knowingly acting together with a  
25                          common goal of jointly acquiring control of a licensee whether or not pursuant to an  
26                          express agreement.

27                          (2) "Authorized agent" means a person that a licensee designates to engage  
28                          in money transmission on behalf of the licensee.

29                          (3) "Average daily money transmission liability" means the amount of the  
30                          licensee's outstanding money transmission obligations in this state at the end of each

1 day in a given period of time, added together and divided by the total number of days  
2 in the given period of time. For purposes of calculating average daily money  
3 transmission liability pursuant to this Chapter for any licensee required to do so, the  
4 given period of time shall be the quarters ending March thirty-first, June thirtieth,  
5 September thirtieth, and December thirty-first.

6 (4) "Bank Secrecy Act" means the Bank Secrecy Act, 31 U.S.C. 5311 et  
7 seq., and its implementing regulations, as amended and recodified from time to time.

8 (5) "Commissioner" means the commissioner of the office of financial  
9 institutions.

10 (6) "Closed loop stored value" means stored value that is redeemable by the  
11 issuer only for goods or services provided by the issuer or its affiliate or franchisees  
12 of the issuer or its affiliate, except to the extent required by applicable law to be  
13 redeemable in cash for its cash value.

14 (7)(a) "Control" means satisfying one of the following:

15 (i) The power to vote, directly or indirectly, at least twenty-five percent of  
16 the outstanding voting shares or voting interests of a licensee or person in control of  
17 a licensee.

18 (ii) The power to elect or appoint a majority of key individuals or executive  
19 officers, managers, directors, trustees, or other persons exercising managerial  
20 authority of a person in control of a licensee.

21 (iii) The power to exercise, directly or indirectly, a controlling influence over  
22 the management or policies of a licensee or person in control of a licensee.

23 (iv) Any other set of facts and circumstances, as determined by the  
24 commissioner in his discretion, that may constitute control.

25 (b) For purposes of determining the percentage of a person controlled by any  
26 other person, the person's interest shall be aggregated with the interest of any other  
27 immediate family member, including the person's spouse, parents, children, siblings,  
28 mothers-in-law and fathers-in-law, sons-in-law and daughters-in-law, brothers-in-law  
29 and sisters-in-law, and any other person who shares the person's home.

1           (8) "Eligible rating" means a credit rating of any of the three highest rating  
2           categories provided by an eligible rating service, whereby each category may include  
3           rating category modifiers such as "plus" or "minus" for Standard & Poors, or the  
4           equivalent for any other eligible rating service. Long-term credit ratings are deemed  
5           eligible if the rating is equal to A- or higher by Standard & Poors, or the equivalent  
6           from any other eligible rating service. Short-term credit ratings are deemed eligible  
7           if the rating is equal to or higher than A-2 or SP-2 by Standard & Poors, or the  
8           equivalent from any other eligible rating service. In the event that ratings differ  
9           among eligible rating services, the highest rating shall apply when determining  
10           whether a security bears an eligible rating.

11           (9) "Eligible rating service" means any Nationally Recognized Statistical  
12           Rating Organization as defined by the United States Securities and Exchange  
13           Commission, and any other organization designated by the commissioner by rule,  
14           regulation, or order.

15           (10) "Federally insured depository financial institution" means a bank, credit  
16           union, savings and loan association, trust company, savings association, savings  
17           bank, industrial bank, or industrial loan company organized pursuant to the laws of  
18           the United States or any state of the United States, if the bank, credit union, savings  
19           and loan association, trust company, savings association, savings bank, industrial  
20           bank, or industrial loan company has federally insured deposits.

21           (11) "In this state" means at a physical location within Louisiana for a  
22           transaction requested in person. For a transaction requested electronically or by  
23           phone, the provider of a money transmission may determine if the person requesting  
24           the transaction is "in this state" by relying on other information provided by the  
25           person regarding the location of the individual's residential address or a business  
26           entity's principal place of business or other physical address location, and any  
27           records associated with the person that the provider of money transmission may have  
28           that indicate such location, including but not limited to an address associated with  
29           an account.

30           (12) "Individual" means a natural person.

1           (13) "Key individual" means any individual ultimately responsible for  
2           establishing or directing policies and procedures of the licensee, such as an executive  
3           officer, manager, director, or trustee.

4           (14) "Licensee" means a person licensed by the office pursuant to this  
5           Chapter.

6           (15) "Material litigation" means litigation, that according to United States  
7           generally accepted accounting principles, is significant to a person's financial health  
8           and would be required to be disclosed in the person's annual audited financial  
9           statements, report to shareholders, or similar records.

10           (16) "Money" means a medium of exchange that is authorized or adopted by  
11           the United States or a foreign government. The term includes a monetary unit of  
12           account established by an intergovernmental organization or by agreement between  
13           two or more governments.

14           (17) "Monetary value" means a medium of exchange, whether or not  
15           redeemable in money.

16           (18) "Money transmission" means any of the following:

17           (a) Selling or issuing payment instruments to a person located in this state.

18           (b) Selling or issuing stored value to a person located in this state.

19           (c) Receiving money or monetary value for transmission from a person  
20           located in this state.

21           (19) "MSB-accredited state" means a state agency that is accredited by the  
22           Conference of State Bank Supervisors and Money Transmitter Regulators  
23           Association for money transmission licensing and supervision.

24           (20) "Multistate licensing process" means any agreement entered into by and  
25           among state regulators relating to coordinated processing of applications for money  
26           transmission licenses, applications for the acquisition of control of a licensee, control  
27           determinations, or notice and information requirements for a change of key  
28           individuals.

29           (21) "NMLS" means the Nationwide Multistate Licensing System and  
30           Registry developed by the Conference of State Bank Supervisors and the American

1 Association of Residential Mortgage Regulators and owned and operated by the  
2 State Regulatory Registry, LLC, or any successor or affiliated entity, for the  
3 licensing and registration of persons in financial services industries.

4 (22) "Office" means the office of financial institutions.

5 (23)(a) "Outstanding money transmission obligations" shall be established  
6 and extinguished in accordance with applicable state law and means one of the  
7 following:

8 (i) Any payment instrument or stored value issued or sold by the licensee to  
9 a person located in the United States or reported as sold by an authorized agent of the  
10 licensee to a person who is located in the United States that has not yet been paid or  
11 refunded by or for the licensee, or escheated in accordance with applicable  
12 abandoned property laws.

13 (ii) Any money received for transmission by the licensee or an authorized  
14 agent in the United States from a person located in the United States that has not  
15 been received by the payee or refunded to the sender, or escheated in accordance  
16 with applicable abandoned property laws.

17 (b) For purposes of this Paragraph, "in the United States" shall include, to  
18 the extent applicable, a person in any state, territory, or possession of the United  
19 States, the District of Columbia, the Commonwealth of Puerto Rico, or a United  
20 States military installation that is located in a foreign country.

21 (24) "Passive investor" means a person who is all of the following:

22 (a) Does not have the power to elect a majority of key individuals or  
23 executive officers, managers, directors, trustees, or other persons exercising  
24 managerial authority of a person in control of a licensee.

25 (b) Is not employed by and does not have any managerial duties of the  
26 licensee or person in control of a licensee.

27 (c) Does not have the power to exercise, directly or indirectly, a controlling  
28 influence over the management or policies of a licensee or person in control of a  
29 licensee.

1           (d) Either attests to Subparagraphs (a), (b), and (c) of this Paragraph, in a  
2           form and in a medium prescribed by the commissioner, or commits to the passivity  
3           characteristics of Subparagraphs (a), (b), and (c) of this Paragraph in a written  
4           document.

5           (25) "Payment instrument" means a written or electronic check, draft, money  
6           order, traveler's check, or other written or electronic instrument for the transmission  
7           or payment of money or monetary value, whether or not negotiable. "Payment  
8           instrument" does not include stored value or any instrument that is either of the  
9           following:

10           (a) Is redeemable by the issuer only for goods or services provided by the  
11           issuer or its affiliate or franchisees of the issuer or its affiliate, except to the extent  
12           required by applicable law to be redeemable in cash for its cash value.

13           (b) Is not sold to the public but issued and distributed as part of a loyalty,  
14           rewards, or promotional program.

15           (26) "Payroll processing service provider" means a person receiving money  
16           for transmission, on its own behalf, on behalf of its affiliate, or pursuant to a contract  
17           with a person to deliver wages or salaries, make payment of payroll taxes to state and  
18           federal agencies, make payments relating to employee benefit plans, or make  
19           distributions of other authorized deductions from wages or salaries.

20           (27)(a) "Person" means an individual, general partnership, limited  
21           partnership, limited liability company, corporation, trust, association, joint stock  
22           corporation, or other legal entity, or any individual or group of individuals, however  
23           organized.

24           (b) "Person" does not include a public corporation, government, or  
25           governmental subdivision, agency, or instrumentality.

26           (28) "Receipt" means a paper receipt, electronic record, or other written  
27           confirmation.

28           (29) "Receiving money for transmission" or "money received for  
29           transmission" means receiving money or monetary value in the United States for  
30           transmission within or outside the United States by electronic or other means.

1                   (30)(a) "Resident" means any of the following:

2                   (i) A person who is domiciled in this state.

3                   (ii) A person who is physically located in this state for more than one  
4                   hundred eighty-three calendar days of the previous three hundred sixty-five calendar  
5                   days.

6                   (iii) A person who has a place of business in this state.

7                   (b) "Resident" includes a legal representative of a person who meets one of  
8                   the criteria provided for in Subparagraph (a) of this Paragraph.

9                   (31)(a) "Stored value" means monetary value representing a claim against  
10                  the issuer evidenced by an electronic or digital record, and that is intended and  
11                  accepted for use as a means of redemption for money or monetary value, or payment  
12                  for goods or services. "Stored value" includes but is not limited to "prepaid access"  
13                  as defined by 31 CFR 1010.100, as amended or recodified from time to time.

14                  (b) Notwithstanding Subparagraph (a) of this Paragraph, "stored value" does  
15                  not include a payment instrument or closed loop stored value, or stored value not  
16                  sold to the public but issued and distributed as part of a loyalty, rewards, or  
17                  promotional program.

18                  (32) "Tangible net worth", for purposes of calculating the value thereof,  
19                  means all business assets minus liabilities and intangible assets, including goodwill  
20                  and other intangible assets. For the purposes of this Paragraph, an intangible asset  
21                  may include but is not limited to favorable leasehold rights, trademarks, trade names,  
22                  internet domain names, and noncompete agreements.

23                  §1034. Exemptions

24                  This Chapter does not apply to:

25                  (1) An operator of a payment system to the extent that it provides processing,  
26                  clearing, or settlement services, between or among persons exempted by this Section  
27                  or licensees, in connection with wire transfers, credit card transactions, debit card  
28                  transactions, stored value transactions, automated clearing house transfers, or similar  
29                  funds transfers.

1           (2) A person appointed as an agent of a payee to collect and process a  
2           payment from a payor to the payee for goods or services, other than money  
3           transmission itself, provided to the payor by the payee, provided that all of the  
4           following apply:

5                   (a) There exists a written agreement between the payee and the agent  
6                   directing the agent to collect and process payments from payors on the payee's  
7                   behalf.

8                   (b) The payee holds the agent out to the public as accepting payments for  
9                   goods or services on the payee's behalf.

10                   (c) Payment for the goods and services is treated as received by the payee  
11                   upon receipt by the agent so that the payor's obligation is extinguished and there is  
12                   no risk of loss to the payor if the agent fails to remit the funds to the payee.

13           (3) A person who acts as an intermediary by processing payments between  
14           an entity that has directly incurred an outstanding money transmission obligation to  
15           a sender, and the sender's designated recipient, provided that the entity meets all of  
16           the following qualifications:

17                   (a) Is properly licensed or exempt from licensing requirements of this  
18                   Chapter.

19                   (b) Provides a receipt, electronic record, or other written confirmation to the  
20                   sender identifying the entity as the provider of money transmission in the transaction.

21                   (c) Bears sole responsibility to satisfy the outstanding money transmission  
22                   obligation to the sender, including the obligation to make the sender whole in  
23                   connection with any failure to transmit the funds to the sender's designated recipient.

24                   (4) The United States or a department, agency, or instrumentality thereof, or  
25                   its agent.

26                   (5) Money transmission by the United States Postal Service or by an agent  
27                   of the United States Postal Service.

28                   (6) A state, county, parish, city, or any other governmental agency or  
29                   governmental subdivision or instrumentality of a state, or its agent.

1           (7) A federally insured depository financial institution, a wholly owned  
2           subsidiary of a federally insured depository institution, bank holding company, office  
3           of an international banking corporation, foreign bank that establishes a federal  
4           branch pursuant to the International Bank Act, 12 U.S.C. 3102, as amended or  
5           recodified from time to time, corporation organized pursuant to the Bank Service  
6           Company Act, 12 U.S.C. 1861 through 1867, as amended or recodified from time to  
7           time, or corporation organized in accordance with the Edge Act, 12 U.S.C. 611  
8           through 633, as amended or recodified from time to time.

9           (8) Electronic funds transfer of governmental benefits for a federal, state,  
10          county, parish, or governmental agency by a contractor on behalf of the United  
11          States or a department, agency, or instrumentality thereof, or on behalf of a state or  
12          governmental subdivision, agency, or instrumentality thereof.

13          (9) A board of trade designated as a contract market pursuant to the federal  
14          Commodity Exchange Act, 7 U.S.C. 1 through 25, both inclusive, as amended or  
15          recodified from time to time, or a person who, in the ordinary course of business,  
16          provides clearance and settlement services for a board of trade to the extent of its  
17          operation as or for such a board.

18          (10) A registered futures commission merchant pursuant to the federal  
19          commodities laws to the extent of its operation as such a merchant.

20          (11) A person registered as a securities broker-dealer pursuant to federal or  
21          state securities laws to the extent of its operation as such a broker-dealer.

22          (12) An individual employed by a licensee, authorized agent, or any person  
23          exempted from the licensing requirements of this Chapter when acting within the  
24          scope of employment and under the supervision of the licensee, authorized agent, or  
25          exempted person as an employee and not as an independent contractor.

26          (13) A person expressly appointed as a third-party service provider to or  
27          agent of an entity exempted in accordance with Paragraph (7) of this Section, solely  
28          to the extent that both of the following occur:

1           (a) The service provider or agent is engaging in money transmission on  
 2           behalf of and pursuant to a written agreement with the exempt entity that sets forth  
 3           the specific functions that the service provider or agent is to perform.

4           (b) The exempt entity assumes all risk of loss and all legal responsibility for  
 5           satisfying the outstanding money transmission obligations owed to purchasers and  
 6           holders of the outstanding money transmission obligations upon receipt of the  
 7           purchaser's or holder's money or monetary value by the service provider or agent.

8           (14) A person exempt by regulation or order if the commissioner finds such  
 9           exemption to be in the public interest and that the regulation of such person is not  
 10          necessary for the purposes of this Chapter.

11          (15) A payroll processing service provider.

12          (16) A licensed lender using stored value cards, debit cards, or electronic  
 13          cash for loan disbursement pursuant to the Louisiana Consumer Credit Law.

14          §1035. Authority to require demonstration of exemption

15          The commissioner may require that any person claiming to be exempt from  
 16          licensing pursuant to R.S. 6:1034 to provide information and documentation to the  
 17          office demonstrating that he qualifies for any claimed exemption.

18          §1036. Implementation

19          A. In addition to any other powers the commissioner may be authorized to  
 20          exercise pursuant to this Title, the commissioner may adopt and implement  
 21          emergency rules as the commissioner considers necessary and appropriate to prevent  
 22          or terminate any condition the commissioner reasonably considers to create an  
 23          emergency relative to a particular licensee or to licenses in general, including but not  
 24          limited to suspending the issuance or renewal of a license or suspending some or all  
 25          money transmission activities in this state.

26          B. In order to carry out the purposes of this Chapter, the commissioner may,  
 27          subject to the provisions of R.S. 6:1037, do all of the following:

28          (1) Enter into agreements or relationships with other government officials  
 29          or federal and state regulatory agencies and regulatory associations in order to

1 improve efficiencies and reduce regulatory burden by standardizing methods or  
2 procedures, and sharing resources, records, or related information.

3 (2) Use, hire, contract, or employ analytical systems, methods, or software  
4 to examine or investigate any person as defined in R.S. 6:1033(27).

5 (3) Accept, from other state or federal government agencies or officials,  
6 licensing, examination, or investigation reports made by the other state or federal  
7 government agencies or officials.

8 (4) Accept audit reports made by an independent certified public accountant  
9 or other qualified third-party auditor for an applicant or licensee and incorporate the  
10 audit report in any report of examination or investigation.

11 C. The commissioner shall have the broad administrative authority to  
12 administer, interpret, and enforce the provisions of this Chapter, to promulgate rules  
13 or regulations for the implementation of this Chapter, and to recover the cost of  
14 administering and enforcing this Chapter by imposing and collecting proportionate  
15 and equitable fees and costs associated with applications, examinations,  
16 investigations, and other actions required to achieve the purpose of this Chapter.

17 D. Pursuant to the provisions of this Title, including but not limited to R.S.  
18 6:103, all records of the office are strictly confidential and not subject to disclosure.  
19 §1037. Supervision

20 A.(1) Each person required to be licensed and his authorized agent shall  
21 maintain in his office the books, records, and accounts of his money transmission  
22 activities as the commissioner may reasonably require in order to determine whether  
23 the person is complying with the provisions of this Chapter and the rules and  
24 regulations related thereto.

25 (2) Required records may be maintained in any electronic format consistent  
26 with the person's ordinary business practices unless the person receives specific  
27 written instructions from the commissioner to the contrary.

28 (3) The books, records, and accounts shall be maintained separately and  
29 apart from any other business in which the person is involved and shall be kept at the

1 location in the state at which the money transmission activities occurred or at the  
2 person's principal office unless otherwise permitted in writing by the commissioner.

3 (4) Records shall be made available for review or examination at a  
4 nonresidential location approved by the commissioner.

5 B. If the books and records of any person described in this Section are  
6 located outside of the state, he shall make them available to the commissioner at a  
7 location within this state convenient to the commissioner or pay the reasonable and  
8 necessary expenses for the commissioner or his representative to examine them at  
9 the place where they are maintained. The commissioner may designate  
10 representatives, including comparable officials of the state in which the records are  
11 located, to inspect the records on his behalf.

12 C. The licensee shall pay an examination fee of fifty dollars per hour for  
13 each examiner, plus the actual cost of subsistence, lodging, and transportation for  
14 out-of-state examinations, not to exceed the amounts provided for in the division of  
15 administration travel regulations in force at the time of the examination. If the  
16 examination fee is not paid within thirty calendar days of its assessment, the person  
17 examined shall be subject to an administrative penalty.

18 D. In addition to any other powers or authority granted in this Title, the  
19 commissioner may at any time do any of the following:

20 (1) Conduct on-site examination or investigation, participate in a joint or  
21 concurrent examination or investigation with another state or federal agency or  
22 agencies, or examine or investigate the books, records, and accounts used in the  
23 business of every licensee.

24 (2) Accept and rely upon an examination report or investigative report of any  
25 other state or federal agency.

26 E. Nothing in Subsection D of this Section shall preclude the commissioner  
27 from conducting an examination or investigation in accordance with applicable  
28 provisions of this Chapter, including but not limited to any of the following:

29 (1) Participating in a joint examination or investigation.  
30

1                   (2) Participating in a concurrent examination or investigation.

2                   (3) Accepting results of an examination or investigation report conducted by  
 3                   any state or federal agency.

4                   F. A joint report or concurrent report accepted by the commissioner pursuant  
 5                   to this Section may be accepted as an official report of the office.

6                   G.(1) To efficiently and effectively enforce the provisions of this Chapter  
 7                   and to minimize regulatory burdens, the commissioner may participate in a  
 8                   multistate examination and investigation process for licensees that hold licenses in  
 9                   this state and other states.

10                  (2) As a participant in any multistate examination or investigation, the  
 11                  commissioner may, to the extent provided by law, do all of the following:

12                  (a) Cooperate, coordinate, and share information with other state regulators  
 13                  of money transmission activities.

14                  (b) Enter into written cooperation, coordination, or information-sharing  
 15                  contracts or agreements with organizations made up of other state governmental  
 16                  regulators of money transmission activities.

17                  (c) Cooperate, coordinate, and share information with organizations made  
 18                  up of other state governmental regulators of money transmission activities, if the  
 19                  organizations agree in writing to maintain confidentiality and security of shared  
 20                  information.

21                  (3) Nothing in this Section shall constitute a waiver of the commissioner's  
 22                  authority to do any of the following:

23                  (a) Conduct any examination or investigation authorized by law.

24                  (b) Otherwise take any independent action authorized by law or any rule  
 25                  promulgated in accordance with the Administrative Procedure Act.

26                  (c) Enforce compliance with any order issued pursuant to this Chapter.

27                  (4) The following shall not constitute a waiver of any examination fee  
 28                  provided pursuant to this Chapter or any rule promulgated in accordance with the  
 29                  Administrative Procedure Act:

1           (a) The commissioner's participation in any joint examination or  
 2           investigation.

3           (b) The commissioner's acceptance of an examination or investigative report  
 4           conducted and prepared by other state or federal regulators of money transmission  
 5           activity.

6           §1038. Networked supervision

7           A. To efficiently and effectively administer and enforce this Chapter and to  
 8           minimize regulatory burden, the commissioner is authorized to participate in  
 9           multistate supervisory processes established between states and coordinated through  
 10          the Conference of State Bank Supervisors, the Money Transmitter Regulators  
 11          Association, and affiliates and successors thereof, for all licensees that hold licenses  
 12          in this state and other states. As a participant in multistate supervision, the  
 13          commissioner may do any of the following:

14           (1) Cooperate, coordinate, and share information with other state and federal  
 15           regulators in accordance with the provisions of this Title.

16           (2) Enter into written cooperation, coordination, or information-sharing  
 17           contracts, or agreements with organizations the membership of which is made up of  
 18           state or federal governmental agencies.

19           (3) Cooperate, coordinate, and share information with organizations in  
 20           accordance with the provisions of this Title, the membership of which is made up of  
 21           state or federal governmental agencies, provided that the organizations agree in  
 22           writing to maintain the confidentiality and security of the shared information.

23           B. The commissioner may not waive, and nothing in this Section constitutes  
 24           a waiver of, the commissioner's authority to conduct an examination or investigation  
 25           or otherwise take independent action authorized by this Chapter or a rule or  
 26           regulation adopted, or order issued relative thereto to enforce compliance with  
 27           applicable state or federal law.

28           C. A joint examination or investigation, or acceptance of an examination or  
 29           investigation report, does not waive an examination fee provided for in this Chapter.

1           §1039. License required

2                   A. A person may not engage in the business of money transmission or  
 3                   advertise, solicit, or hold itself out as providing money transmission unless the  
 4                   person is licensed pursuant to this Chapter.

5                   B. Subsection A of this Section does not apply to any of the following:

6                   (1) A person who is an authorized agent of a person licensed in accordance  
 7                   with this Chapter acting within the scope of authority conferred by a written contract  
 8                   with the licensee.

9                   (2) A person who is exempt pursuant to R.S. 6:1034 and does not engage in  
 10                   money transmission outside the scope of such exemption.

11                   C. A license issued pursuant to R.S. 6:1043 is not transferable or assignable.

12           §1040. Consistent state licensing

13                   A. To establish consistent licensing between this state and other states, the  
 14                   commissioner may:

15                   (1) Implement all licensing provisions of this Chapter in a manner that is  
 16                   consistent with other states that have adopted similar laws or multistate licensing  
 17                   processes.

18                   (2) Participate in nationwide protocols for licensing cooperation and  
 19                   coordination among state regulators if such protocols are consistent with this  
 20                   Chapter.

21                   B. In order to fulfill the purposes of this Chapter, the commissioner may  
 22                   establish relationships or contracts with NMLS or other entities designated by NMLS  
 23                   to enable the commissioner to do all of the following:

24                   (1) Collect and maintain records.

25                   (2) Coordinate multistate licensing processes and supervision processes.

26                   (3) Process fees.

27                   (4) Facilitate communication between the state and licensees or other  
 28                   persons.

29                   C. The commissioner may utilize NMLS for all aspects of licensing,  
 30                   including but not limited to license applications, applications for acquisitions of

1 control, surety bonds, reporting, criminal history background checks, credit checks,  
2 fee processing, and examinations.

3 D. The commissioner may utilize NMLS forms, processes, and  
4 functionalities. In the event NMLS does not provide functionality, forms, or  
5 processes, the commissioner may strive to implement the requirements of this  
6 Section in a manner that facilitates uniformity with respect to licensing, supervision,  
7 reporting, and regulation of licensees which are licensed in multiple jurisdictions.

8 E. Every person required to be licensed shall register with NMLS and be  
9 subject to such registration and renewal requirements as may be established by  
10 NMLS in addition to any requirements of this Chapter.

11 §1041. Application for license

12 A. Applicants for a license shall apply in a form and in a medium as  
13 prescribed by the commissioner. Each such form shall contain content as set forth  
14 by rule, regulation, instruction, or procedure of the commissioner and may be  
15 changed or updated by the commissioner in accordance with applicable law in order  
16 to carry out the purposes of this Chapter and maintain consistency with NMLS  
17 licensing standards and practices. The application shall state or contain, as  
18 applicable:

19 (1) The legal name and residential and business addresses of the applicant  
20 and any fictitious or trade name used by the applicant in conducting his business.

21 (2) A list of any criminal convictions of the applicant and any material  
22 litigation in which the applicant has been involved in the ten-year period next  
23 preceding the submission of the application.

24 (3) A description of any money transmission activities previously provided  
25 by the applicant and the money transmission that the applicant seeks to provide in  
26 this state.

27 (4) A list of the applicant's proposed authorized agent and the locations in  
28 this state where the applicant and its authorized agent propose to engage in money  
29 transmission.

1                   (5) A list of other states in which the applicant is licensed to engage in  
 2                   money transmission and any license revocations, suspensions, or other disciplinary  
 3                   action taken against the applicant in another state.

4                   (6) Information concerning any bankruptcy or receivership proceedings  
 5                   affecting the licensee or a person in control of a licensee.

6                   (7) A sample form of contract for authorized agent, if applicable.

7                   (8) The source of funds and credit to be used by the applicant to conduct  
 8                   money transmission activities with, or on behalf of, an individual and documentation  
 9                   demonstrating that the applicant has the tangible net worth required pursuant to R.S.  
 10                  6:1059.

11                  (9) Evidence of registration if the applicant is required to register with the  
 12                  Financial Crimes Enforcement Network of the United States Department of Treasury  
 13                  as a money service business.

14                  (10) A sample form of payment instrument or stored value, as applicable.

15                  (11) The name and address of any federally insured depository financial  
 16                  institution through which the applicant plans to conduct money transmission.

17                  (12) An investigative background report prepared by an independent search  
 18                  firm as required by R.S. 6:1042(B) from any key individuals who have resided  
 19                  outside the United States at any time in the last ten years.

20                  (13) Any other information the commissioner or NMLS requires with respect  
 21                  to the applicant.

22                  B. If an applicant is a corporation, limited liability company, partnership, or  
 23                  other legal entity, the applicant shall also provide all of the following:

24                  (1) The date of the applicant's incorporation or formation and state or  
 25                  country of incorporation or formation.

26                  (2) If applicable, a certificate of good standing from the state or country in  
 27                  which the applicant is incorporated or formed.

28                  (3) A brief description of the structure or organization of the applicant,  
 29                  including any parents or subsidiaries of the applicant, and whether any parents or  
 30                  subsidiaries are publicly traded.

1           (4) The legal name, any fictitious or trade name, all business and residential  
2           addresses, and the employment, as applicable, in the ten-year period next preceding  
3           the submission of the application of each key individual and person in control of the  
4           applicant.

5           (5) A list of any criminal convictions and material litigation in which a  
6           person in control of the applicant who is not an individual has been involved in the  
7           ten-year period next preceding the submission of the application.

8           (6) A copy of the audited financial statements of the applicant for the most  
9           recent fiscal year and for the two-year period next preceding the submission of the  
10           application.

11           (7) A certified copy of the unaudited financial statements of the applicant for  
12           the most recent fiscal quarter.

13           (8) If the applicant is a publicly traded corporation, a copy of the most recent  
14           report filed with the United States Securities and Exchange Commission in  
15           accordance with Section 13 of the Securities Exchange Act of 1934, 15 U.S.C. 78m,  
16           as amended or recodified from time to time.

17           (9) If the applicant is a wholly owned subsidiary of one of the following:

18           (a) A corporation publicly traded in the United States, a copy of audited  
19           financial statements for the parent corporation for the most recent fiscal year or a  
20           copy of the parent corporation's most recent report filed in accordance with Section  
21           13 of the Securities Exchange Act of 1934, 15 U.S.C. 78m, as amended or recodified  
22           from time to time.

23           (b) A corporation publicly traded outside the United States, a copy of similar  
24           documentation filed with the regulator of the parent corporation's domicile outside  
25           the United States.

26           (10) The name and address of the applicant's registered agent in this state.

27           (11) Any other information the commissioner may require with respect to the  
28           applicant.

29           C. A nonrefundable application fee of one thousand five hundred dollars  
30           shall accompany an application for a license pursuant to this Section. However,

1 beginning with calendar year 2026 and for each subsequent calendar year, on or  
2 before July first of the following year, the commissioner shall issue a memo  
3 authorizing a new application fee in accordance with this Section. The new amount  
4 will be calculated by applying any increase or decrease in the United States Bureau  
5 of Labor Statistics Consumer Price Index for All Urban Consumers for the previous  
6 calendar year to the previous year's license fee amount and rounding that amount  
7 upward to the nearest one-hundred-dollar increment.

8 D. If any material information provided in connection with an application  
9 changes during the application review period, the applicant shall immediately notify  
10 the commissioner.

11 §1042. Information requirements for certain persons

12 A. Any person in control of a licensee or applicant, any person who seeks  
13 to acquire control of a licensee, and each key individual shall furnish to the  
14 commissioner through NMLS all of the following items:

15 (1) The person's fingerprints for submission to the Federal Bureau of  
16 Investigation and the commissioner for purposes of a national criminal history  
17 background check unless the person currently resides outside of the United States  
18 and has resided outside of the United States for the last ten years.

19 (2) Personal history and experience in a form and in a medium prescribed by  
20 the commissioner, to obtain both of the following:

21 (a) Information related to any criminal convictions or pending charges,  
22 provided an applicant shall not have been convicted of a felony in any jurisdiction  
23 or a misdemeanor of fraud, theft, forgery, bribery, embezzlement, or making a  
24 fraudulent or false statement in any jurisdiction.

25 (b) Information related to any regulatory or administrative action and any  
26 civil litigation involving claims of fraud, misrepresentation, conversion,  
27 mismanagement of funds, breach of fiduciary duty, or breach of contract.

28 B. If the person has resided outside of the United States at any time in the  
29 last ten years, the person shall also provide an investigative background report  
30 prepared by an independent search firm that meets all of the following requirements:

1                   (1) At a minimum, the search firm shall do all of the following:

2                   (a) Demonstrate that it has sufficient knowledge, resources, and employs  
3                   accepted and reasonable methodologies to conduct the research for the background  
4                   report.

5                   (b) Not be affiliated with or have any direct or indirect interest in or with the  
6                   individual it is researching.

7                   (2) At a minimum, the investigative background report shall be written in the  
8                   English language and shall contain all of the following:

9                   (a) If available in the person's current jurisdiction of residency, a  
10                  comprehensive credit report, or any equivalent information obtained or generated by  
11                  the independent search firm to accomplish such report, including a search of the  
12                  court data in the countries, provinces, states, cities, towns, and contiguous areas  
13                  where the individual resided and worked.

14                  (b) Criminal records information for the past ten years, including but not  
15                  limited to felonies, misdemeanors, or similar convictions for violations of law in the  
16                  countries, provinces, states, cities, towns, and contiguous areas where the individual  
17                  resided and worked.

18                  (c) Employment history.

19                  (d) Media history, including an electronic search of national and local  
20                  publications, wire services, and business applications.

21                  (e) Financial services-related regulatory history, including but not limited to  
22                  money transmission, securities, banking, insurance, and mortgage-related industries.

23                  §1043. Issuance of license

24                  A. When the commissioner determines that an application is complete, the  
25                  commissioner shall promptly notify the applicant in a record of the date on which the  
26                  application is determined to be complete and one of the following will occur:

27                  (1) The commissioner shall approve or deny the application within one  
28                  hundred twenty calendar days after the completion date.

29                  (2) If the application is not approved or denied within one hundred twenty  
30                  calendar days after the completion date all of the following will occur:

1                   (a) The application is deemed approved.

2                   (b) The license takes effect as of the first business day after expiration of the  
 3 one-hundred-twenty-day period.

4                   (3) The commissioner may for good cause extend the application period.

5                   B. A determination by the commissioner that an application is complete and  
 6 is accepted for processing means only that the application, on its face, appears to  
 7 include all of the items, including the criminal background check response from the  
 8 Federal Bureau of Investigation, and address all of the matters that are required, and  
 9 is not an assessment of the substance of the application or of the sufficiency of the  
 10 information provided.

11                  C. When an application is filed and considered complete pursuant to this  
 12 Section, the commissioner shall investigate the applicant's financial condition and  
 13 responsibility, financial and business experience, character, and general fitness. The  
 14 commissioner may conduct an on-site investigation of the applicant, the cost of  
 15 which the applicant shall pay. The commissioner shall issue a license to an applicant  
 16 pursuant to this Section if the commissioner finds that all of the following conditions  
 17 have been fulfilled:

18                   (1) The applicant has complied with R.S. 6:1041 and 1042.

19                   (2) The applicant's financial condition and responsibility are compliant with  
 20 R.S. 6:1059, 1060, and 1061, and the financial and business experience, competence,  
 21 character, and general fitness of the applicant, and the competence, experience,  
 22 character, and general fitness of the key individuals and persons in control of the  
 23 applicant indicate that it is in the interest of the public to permit the applicant to  
 24 engage in money transmission.

25                  D. If an applicant avails himself or is otherwise subject to a multistate  
 26 licensing process one of the following applies:

27                   (1) The commissioner may accept the investigation results of a lead  
 28 investigative state for the purpose of Subsection C of this Section if the lead  
 29 investigative state has sufficient staffing, expertise, and minimum standards.

1           (2) If Louisiana is a lead investigative state, the commissioner may  
 2           investigate the applicant pursuant to Subsection C of this Section and the timeframes  
 3           established by agreement through the multistate licensing process, provided,  
 4           however, that in no case shall such timeframe be noncompliant with the application  
 5           period in Paragraph (A)(1) of this Section.

6           E.(1) The commissioner shall issue a formal written notice of the denial of  
 7           a license application. The commissioner shall set forth in the notice of denial the  
 8           reasons for the denial of the application.

9           (2) The applicant may appeal within thirty calendar days after receipt of the  
 10          written notice of the denial. If the office has not received the applicant's request for  
 11          appeal within that period, then the applicant is deemed to have waived all rights of  
 12          appeal. All appeals shall be in accordance with the Administrative Procedure Act.

13          F. If an applicant for a license pursuant to this Chapter does not complete the  
 14          license application and fails to respond to a notice or notices from the commissioner  
 15          to correct a deficiency or deficiencies for a period of one hundred twenty calendar  
 16          days or more after the date the commissioner sends the initial notice to correct the  
 17          deficiency or deficiencies, the office may deem the application as abandoned and  
 18          may issue a notice of abandonment of the application to the applicant in lieu of  
 19          proceedings to deny the application.

20          G. The initial license term shall begin on the day the application is approved.  
 21          The license shall expire on December thirty-first of the year in which the license  
 22          term began, unless the initial license date is between November first and December  
 23          thirty-first, in which instance the initial license term shall expire on December thirty-  
 24          first of the following year.

25          §1044. Renewal of license

26          A.(1) Each person licensed as a money transmitter in accordance with this  
 27          Chapter shall submit an annual license renewal application and a nonrefundable fee  
 28          in the amount of eight hundred dollars, plus one hundred dollars for each location in  
 29          excess of one in Louisiana through which the licensee plans to conduct money  
 30          transmission during the license year for which the fee is paid, shall be paid, provided

1 that in no event shall the annual renewal fee exceed six thousand dollars. The annual  
2 renewal application fee shall be submitted on or before December thirty-first of each  
3 year in a manner and form prescribed by the commissioner and submit to the  
4 commissioner a renewal report pursuant to Paragraph (B)(3) of this Section if the  
5 person is not issued a new license from November first to December thirty-first of  
6 that year. A money transmission license issued during this time period will expire  
7 on December thirty-first of the following calendar year.

8 (2) An annual renewal application shall be accompanied by the required  
9 annual license renewal fees, as required pursuant to Paragraph (1) of this Subsection.  
10 An annual license renewal application submitted after December thirty-first and  
11 before March first of the following year shall be charged a nonrefundable annual  
12 license renewal late fee in the amount of six hundred dollars, in addition to the  
13 annual license renewal fee.

14 B.(1) If the annual renewal application is submitted timely on or before  
15 December thirty-first, the license shall remain in force and effect until the renewal  
16 application is either approved or denied by the commissioner. Nothing in this  
17 Paragraph shall preclude the commissioner from implementing any administrative  
18 or enforcement action authorized by this Chapter for violations of this Chapter or for  
19 any material representation that may have occurred prior to the renewal date of a  
20 license.

21 (2) If the commissioner has not received the renewal fee and late fee before  
22 March first, the license to engage in money transmission activities shall expire  
23 without a hearing or notification, and the license shall not be reinstated. However,  
24 the person whose license has expired may apply for a new license, subject to all new  
25 license application requirements of this Chapter. Prior to such application being  
26 complete and eligible for approval consideration, the applicant shall be subject to and  
27 pay unlicensed activity civil money penalties in an amount determined by the  
28 commissioner.

29 (3) A licensee shall submit a renewal report with the renewal fee, in a form  
30 and in a manner prescribed by the commissioner. The renewal report shall state or

1           contain a description of each material change in information submitted by the  
 2           licensee in its original license application and which has not been previously reported  
 3           to the commissioner.

4                     (4) The commissioner may utilize NMLS to process license renewals if such  
 5                     functionality is consistent with this Section.

6           §1045. Maintenance of license

7                     A. If a licensee does not continue to meet the qualifications or satisfy the  
 8                     requirements that apply to an applicant for a new money transmission license, the  
 9                     commissioner may suspend or revoke the licensee's license in accordance with the  
 10                    procedures established by this Chapter or other applicable state law for such  
 11                    suspension or revocation.

12                    B. An applicant for a money transmission license shall demonstrate that he  
 13                    meets or will meet, and a money transmission licensee shall at all times meet, the  
 14                    requirements in R.S. 6:1059, 1060, and 1061.

15           §1046. Acquisition of control

16                    A. Any person, or group of persons acting in concert, seeking to acquire  
 17                    control of a licensee shall obtain the written approval of the commissioner prior to  
 18                    acquiring control.

19                    B. A person, or group of persons acting in concert, seeking to acquire control  
 20                    of a licensee shall, in cooperation with the licensee, do both of the following:

21                             (1) Submit an application in a form and in a manner prescribed by the  
 22                             commissioner.

23                             (2) Submit a nonrefundable fee of one thousand five hundred dollars as  
 24                             required in accordance with R.S. 6:1041 with the request for approval.

25                    C. Upon request, the commissioner may permit a licensee or the person, or  
 26                    group of persons acting in concert, to submit some or all information required by the  
 27                    commissioner pursuant to Paragraph (B)(1) of this Section without using NMLS.

28                    D. The application required by Paragraph (B)(1) of this Section shall include  
 29                    information required by R.S. 6:1042 for any new key individuals who have not  
 30                    previously completed the requirements of R.S. 6:1041 for a licensee.

1                   E.(1) When the commissioner determines an application for acquisition of  
 2                   control in accordance with this Section appears to include all the items and addresses  
 3                   all of the matters that are required, the application shall be considered complete, and  
 4                   the commissioner shall do all of the following:

5                   (a) Promptly notify the applicant in a record of the date on which the  
 6                   application was determined to be complete.

7                   (b) Approve or deny the application within sixty calendar days after the  
 8                   completion date.

9                   (2) If the application is not approved or denied within sixty calendar days  
 10                  after the completion date, both of the following apply:

11                  (a) The application is approved.

12                  (b) The person, or group of persons acting in concert, is not prohibited from  
 13                  acquiring control.

14                  (3) The commissioner may for good cause extend the application period.

15                  F. A determination by the commissioner that an application is complete and  
 16                  is accepted for processing means only that the application, on its face, appears to  
 17                  include all of the items and address all of the matters that are required, and is not an  
 18                  assessment of the substance of the application or of the sufficiency of the  
 19                  information provided.

20                  G. When an application is filed and considered complete in accordance with  
 21                  Subsection E of this Section, the commissioner shall investigate the financial  
 22                  condition and responsibility, financial and business experience, character, and  
 23                  general fitness of the person, or group of persons acting in concert, seeking to  
 24                  acquire control. The commissioner shall approve an acquisition of control pursuant  
 25                  to this Section if the commissioner finds that all of the following conditions have  
 26                  been fulfilled:

27                  (1) The requirements of Subsections B and D of this Section, and the  
 28                  provisions of R.S. 6:1059, 1060, and 1061 have been met, as applicable.

29                  (2) The financial condition and responsibility, financial and business  
 30                  experience, competence, character, and general fitness of the person, or group of

1 persons acting in concert, seeking to acquire control, and the competence,  
2 experience, character, and general fitness of the key individuals and persons that  
3 would be in control of the licensee after the acquisition of control indicate that it is  
4 in the interest of the public to permit the person, or group of persons acting in  
5 concert, to control the licensee.

6 H. If an applicant avails himself or is otherwise subject to a multistate  
7 licensing process:

8 (1) The commissioner may accept the investigation results of a lead  
9 investigative state for the purpose of Subsection G of this Section if the lead  
10 investigative state has sufficient staffing, expertise, and minimum standards.

11 (2) If Louisiana is a lead investigative state, the commissioner may  
12 investigate the applicant pursuant to Subsection G of this Section and the timeframes  
13 established by agreement through the multistate licensing process.

14 I.(1) The commissioner shall issue a formal written notice of the denial of  
15 an application to acquire control. The commissioner shall set forth in the notice of  
16 denial the reasons for the denial of the application.

17 (2) The applicant may appeal within thirty calendar days after receipt of the  
18 written notice of the denial. If the office has not received the applicant's request for  
19 appeal within that period, then the applicant is deemed to have waived all rights of  
20 appeal. All appeals shall be in accordance with the Administrative Procedure Act.

21 J. The requirements of Subsections A and B of this Section do not apply to  
22 any of the following:

23 (1) A person who acts as a proxy for the sole purpose of voting at a  
24 designated meeting of the shareholders or holders of voting shares or voting interests  
25 of a licensee or a person in control of a licensee.

26 (2) A person who acquires control of a licensee by devise or descent,  
27 provided the person has not been convicted of a felony offense and is in compliance  
28 with R.S. 6:1043.

1           (3) A person who acquires control of a licensee as a personal representative,  
2           custodian, guardian, conservator, or trustee, or as an officer appointed by a court of  
3           competent jurisdiction or by operation of law.

4           (4) A person who is exempt pursuant to R.S. 6:1034(7).

5           (5) A person who the commissioner determines is not subject to Subsection  
6           A of this Section based on the public interest.

7           (6) A public offering of securities of a licensee or a person in control of a  
8           licensee.

9           (7) An internal reorganization of a person in control of the licensee where  
10          the ultimate person in control of the licensee remains the same.

11          K. Persons outlined in Paragraphs (J)(2) through (7) of this Section in  
12          cooperation with the licensee shall notify the commissioner within fifteen calendar  
13          days after the acquisition of control.

14          L.(1) The requirements of Subsections A and B of this Section do not apply  
15          to a person who has complied with and received approval to engage in money  
16          transmission pursuant to this Chapter or was identified as a person in control in a  
17          prior application filed with and approved by the commissioner or by an  
18          MSB-accredited state pursuant to a multistate licensing process, if all of the  
19          following applies:

20           (a) The person has not had a license revoked or suspended or controlled a  
21           licensee that has had a license revoked or suspended while the person was in control  
22           of the licensee in the previous five years.

23           (b) If the person is a licensee, the person is well managed and has received  
24           at least a satisfactory rating for compliance at its most recent examination by an  
25           MSB-accredited state if such rating was given.

26           (c) The licensee to be acquired is projected to meet the requirements of R.S.  
27           6:1059, 1060, and 1061 after the acquisition of control is completed, and if the  
28           person acquiring control is a licensee, that licensee is also projected to meet the  
29           requirements of R.S. 6:1059, 1060, and 1061 after the acquisition of control is  
30           completed.

1           (d) The licensee to be acquired will not implement any material changes to  
2           its business plan as a result of the acquisition of control, and if the person acquiring  
3           control is a licensee, that licensee also will not implement any material changes to  
4           its business plan as a result of the acquisition of control.

5           (e) The person provides notice of the acquisition in cooperation with the  
6           licensee and attests to Subparagraphs (a) through (d) of this Paragraph in a form and  
7           in a medium prescribed by the commissioner.

8           (2) If the notice is not disapproved within thirty calendar days after the date  
9           on which the notice was determined to be complete, the notice is deemed approved.

10           (3) Before filing an application for approval to acquire control of a licensee  
11           a person may request in writing a determination from the commissioner as to  
12           whether the person would be considered a person in control of a licensee upon  
13           consummation of a proposed transaction. If the commissioner determines that the  
14           person would not be a person in control of a licensee, the proposed person and  
15           transaction are not subject to the requirements of Subsections A and B of this  
16           Section.

17           M. If a multistate licensing process includes a determination pursuant to  
18           Paragraph (L)(3) of this Section and an applicant avails itself or is otherwise subject  
19           to the multistate licensing process:

20           (1) The commissioner may accept the control determination of a lead  
21           investigative state with sufficient staffing, expertise, and minimum standards for the  
22           purpose of Paragraph (L)(3) of this Section.

23           (2) If Louisiana is a lead investigative state, the commissioner may  
24           investigate the applicant pursuant to this Subsection and the timeframes established  
25           by agreement through the multistate licensing process.

26           §1047. Notice and information requirements for a change of key individuals

27           A.(1) A licensee adding or replacing any key individual shall do both of the  
28           following:

29           (a) Provide notice in a manner prescribed by the commissioner within fifteen  
30           calendar days after the effective date of the key individual's appointment.

1           (b) Provide information as required by R.S. 6:1042 within forty-five calendar  
2           days of the effective date of the key individual's appointment.

3           (2) Within ninety calendar days of the date on which the notice provided  
4           pursuant to Paragraph (1) of this Subsection was determined to be complete, the  
5           commissioner may issue a notice of disapproval of a key individual if the  
6           competence, experience, character, or integrity of the individual would not be in the  
7           best interests of the public or the customers of the licensee to permit the individual  
8           to be a key individual of such licensee.

9           (3)(a) A notice of disapproval shall contain a statement of the basis for  
10           disapproval and shall be sent to the licensee and the disapproved individual.

11           (b) The licensee may appeal within thirty calendar days after receipt of the  
12           written notice of the disapproval. If the office has not received the licensee's request  
13           for appeal within that period, then the licensee is deemed to have waived all rights  
14           of appeal. All appeals shall be in accordance with the Administrative Procedure Act.

15           (4) If the notice provided pursuant to Paragraph (1) of this Subsection is not  
16           disapproved within ninety calendar days after the date on which the notice was  
17           determined to be complete, the key individual is deemed approved.

18           B. If a multistate licensing process includes a key individual notice review  
19           and disapproval process pursuant to this Section and the licensee avails itself or is  
20           otherwise subject to the multistate licensing process:

21           (1) The commissioner may accept the determination of another state if the  
22           investigating state has sufficient staffing, expertise, and minimum standards for the  
23           purpose of this Section.

24           (2) If Louisiana is a lead investigative state, the commissioner may  
25           investigate the applicant pursuant to this Subsection and the timeframes established  
26           by agreement through the multistate licensing process.

27           §1048. Report of condition

28           A. Each licensee shall submit a report of condition, which shall be known  
29           as a Call Report, within forty-five calendar days of the end of the calendar quarter,  
30           or within any extended time as the commissioner may prescribe.

1 B.(1) The report of condition shall include all of the following:

2 (a) Financial information at the licensee level.

3 (b) Nationwide and state-specific money transmission transaction  
 4 information in every jurisdiction in the United States where the licensee is licensed  
 5 to engage in money transmission.

6 (c) Permissible investments report.

7 (d) Transaction destination country reporting for money received for  
 8 transmission, if applicable.

9 (e) Any other information the commissioner requires with respect to the  
 10 licensee.

11 (2) The commissioner may utilize NMLS for the submission of the report  
 12 required by Subsection A of this Section and is authorized to change or update as  
 13 necessary the requirements of this Section to carry out the purposes of this Chapter  
 14 and maintain consistency with NMLS reporting.

15 C. The information required by Paragraph (B)(1) of this Section shall only  
 16 be included in a report of condition submitted within forty-five calendar days of the  
 17 end of the fourth calendar quarter.

18 §1049. Audited financials

19 A. Each licensee shall, within ninety calendar days after the end of each  
 20 fiscal year, or within any extended time as the commissioner may prescribe, file with  
 21 the commissioner both of the following:

22 (1) An audited financial statement of the licensee for the fiscal year prepared  
 23 in accordance with United States Generally Accepted Accounting Principles.

24 (2) Any other information as the commissioner may require.

25 B. The audited financial statements shall be prepared by an independent  
 26 certified public accountant or independent public accountant who is satisfactory to  
 27 the commissioner.

28 C. The audited financial statements shall include or be accompanied by a  
 29 certificate of opinion of the independent certified public accountant or independent  
 30 public accountant that is satisfactory in form and content to the commissioner. If the

1           certificate or opinion is qualified, the commissioner may order the licensee to take  
 2           any action as the commissioner may find necessary to enable the independent or  
 3           certified public accountant or independent public accountant to remove the  
 4           qualification.

5           §1050. Authorized agent reporting

6                   A. Each licensee shall submit a report of authorized agent within forty-five  
 7                   calendar days of the end of the calendar quarter. The commissioner may utilize  
 8                   NMLS for the submission of the report required by this Subsection provided that the  
 9                   functionality is consistent with the requirements of this Section. The utilization shall  
 10                  include the NMLS Uniform Authorized Agent Reporting process, or such other  
 11                  similar process as designated by NMLS.

12                   B. The authorized agent report shall include, at a minimum, each authorized  
 13                  agent's:

- 14                   (1) Company legal name.
- 15                   (2) Taxpayer employer identification number.
- 16                   (3) Principal provider identifier.
- 17                   (4) Physical address.
- 18                   (5) Mailing address.
- 19                   (6) Any business conducted in other states.
- 20                   (7) Any fictitious or trade name.
- 21                   (8) Contact person name, phone number, and email address.
- 22                   (9) Start date as licensee's authorized agent.
- 23                   (10) End date acting as licensee's authorized agent, if applicable.
- 24                   (11) Any other information the commissioner requires with respect to the  
 25                  authorized agent.

26           §1051. Reports of certain events

27                   A. A licensee shall file a report with the commissioner within one business  
 28                  day after the licensee knows or should have known of any of the following events:

1           (1) The filing of a petition by or against the licensee pursuant to the United  
2           States Bankruptcy Code, 11 U.S.C. 101 through 110, both inclusive, as amended or  
3           recodified from time to time, for bankruptcy or reorganization.

4           (2) The filing of a petition by or against the licensee for receivership, the  
5           commencement of any other judicial or administrative proceeding for its dissolution  
6           or reorganization, or the making of a general assignment for the benefit of its  
7           creditors.

8           (3) The commencement of a proceeding to revoke or suspend its license in  
9           a state or country in which the licensee engages in business or is licensed.

10          B.(1) A licensee shall file a report with the commissioner within three  
11          business days after the licensee has reason to know of the occurrence of any of the  
12          following events:

13           (a) An indictment, charge, or conviction of the licensee or of a key individual  
14           or person in control of the licensee for a felony.

15           (b) An indictment, charge, or conviction of an authorized agent for a felony.

16           (2)(a) Except as provided in Subparagraphs (b) and (c) of this Paragraph, a  
17           licensee shall notify the commissioner in writing or through the NMLS within three  
18           business days after the time that the licensee becomes aware of any breach of  
19           security of the system of computerized data owned or licensed by the licensee, which  
20           contains personal information about a Louisiana resident, or the unauthorized access  
21           to or use of such information about a Louisiana resident as a result of the breach. For  
22           purposes of this Subparagraph, the terms breach of the security of the system and  
23           personal information have the same meaning as in R.S. 51:3073.

24           (b) If a licensee would be required pursuant to Louisiana law to provide  
25           notification to a Louisiana resident regarding the breach, then the licensee shall  
26           provide a copy of such notification to the commissioner prior to or simultaneously  
27           with the licensee's notification to the Louisiana resident.

28           (c) Notice required by this Subsection may be delayed if a law enforcement  
29           agency determines that the notice will impede a criminal investigation. Notice shall  
30           be made in good faith and without unreasonable delay as soon as possible after the

1 law enforcement agency determines that notification will no longer impede the  
 2 investigation.

3 §1052. Reports required by federal law

4 A licensee and an authorized agent shall file all reports required by federal  
 5 currency reporting, record keeping, and suspicious activity reporting requirements  
 6 as set forth in the Bank Secrecy Act and other federal and state laws pertaining to  
 7 money laundering. The timely filing of a complete and accurate report required  
 8 pursuant to this Section with the appropriate federal agency is deemed compliant  
 9 with the requirements of this Section.

10 §1053. Records

11 A. A licensee shall maintain all of the following records, for determining his  
 12 compliance with this Chapter for at least five years:

13 (1) A record of each money transmission obligation sold.

14 (2) A general ledger posted at least monthly containing all asset, liability,  
 15 capital, income, and expense accounts.

16 (3) All bank statements and bank reconciliation records.

17 (4) All records of outstanding money transmission, including but not limited  
 18 to a list of residents and the most recent residential address.

19 (5) Records of each outstanding money transmission obligation paid within  
 20 the five-year period.

21 (6) A list of the last-known names and addresses of all of the licensee's  
 22 authorized agents.

23 (7) Any other records the commissioner requires by rule, regulation, or  
 24 order.

25 B. The items specified in Subsection A of this Section shall be maintained  
 26 in written or electronic form.

27 C. Records specified in Subsection A of this Section may be maintained  
 28 outside this state if they are made accessible to the commissioner on seven business  
 29 days' notice that is sent in a record.

1                    D. All records maintained by the licensee as required in Subsections A  
 2                    through C of this Section are subject to inspection by the commissioner pursuant to  
 3                    R.S. 6:1037(A).

4                    E. Each licensee shall maintain written policies and procedures sufficient for  
 5                    it to comply with this Chapter and all other laws and regulations applicable to the  
 6                    conduct of its licensed business.

7                    §1054. Relationship between licensee and authorized agent

8                    A. As used in this Section, "remit" means to make direct payments of money  
 9                    to a licensee or its representative authorized to receive money or to deposit money  
 10                    in a bank in an account specified by the licensee.

11                    B. Before a licensee may conduct business through an authorized agent or  
 12                    allows a person to act as the licensee's authorized agent, the licensee shall do all of  
 13                    the following:

14                    (1) Adopt, and update as necessary, written policies and procedures designed  
 15                    to ensure that the licensee's authorized agents comply with applicable state and  
 16                    federal law.

17                    (2) Enter into a written contract that complies with Subsection E of this  
 18                    Section.

19                    (3) Conduct a reasonable risk-based background investigation sufficient for  
 20                    the licensee to determine whether the authorized agent has complied and will likely  
 21                    comply with applicable state and federal law.

22                    C. The licensee's authorized agents shall operate in full compliance with  
 23                    applicable state and federal law, and the licensee shall be responsible for  
 24                    implementing and maintaining a reasonable risk-based supervision program to  
 25                    monitor its authorized agents.

26                    D. An authorized agent shall operate in full compliance with this Chapter.

27                    E. The written contract required by Paragraph (B)(2) of this Section shall be  
 28                    signed by the licensee and the authorized agent and, at a minimum, shall do all of the  
 29                    following:

1           (1) Appoint the person signing the contract as the licensee's authorized agent  
2           with the authority to conduct money transmission on behalf of the licensee.

3           (2) Set forth the nature and scope of the relationship between the licensee  
4           and the authorized agent and the respective rights and responsibilities of the parties.

5           (3) Require the authorized agent to agree to fully comply with all applicable  
6           state and federal laws, rules, and regulations pertaining to money transmission,  
7           including this Chapter and regulations related thereto, relevant provisions of the  
8           Bank Secrecy Act and the USA PATRIOT Act.

9           (4) Require the authorized agent to remit and handle money and monetary  
10          value in accordance with the terms of the contract between the licensee and the  
11          authorized agent.

12          (5) Impose a trust on money and monetary value net of fees received for  
13          money transmission for the benefit of the licensee.

14          (6) Require the authorized agent to prepare and maintain records as required  
15          by this Chapter or regulations related thereto, or as requested by the commissioner.

16          (7) Acknowledge that the authorized agent consents to examination or  
17          investigation by the commissioner.

18          (8) State that the licensee is subject to regulation by the commissioner and  
19          that, as part of that regulation, the commissioner may suspend or revoke an  
20          authorized agent designation or require the licensee to terminate an authorized agent  
21          designation.

22          (9) Acknowledge receipt of the written policies and procedures required  
23          pursuant to Paragraph (B)(1) of this Section.

24          F. If the licensee's license is suspended, revoked, surrendered, or expired, the  
25          licensee shall, within five business days, provide documentation to the commissioner  
26          that the licensee has notified all applicable authorized agents of the licensee whose  
27          names are in a record filed with the commissioner of the suspension, revocation,  
28          surrender, or expiration of a license. Upon suspension, revocation, surrender, or  
29          expiration of a license, applicable authorized agents shall immediately cease to  
30          provide money transmission as an authorized agent of the licensee.

1           G. An authorized agent of a licensee shall hold in trust for the benefit of the  
 2           licensee all money net of fees received from money transmission. If any authorized  
 3           agent commingles any funds received from money transmission with any other funds  
 4           or property owned or controlled by the authorized agent, all commingled funds and  
 5           other property shall be considered held in trust in favor of the licensee in an amount  
 6           equal to the amount of money net of fees received from money transmission.

7           H. An authorized agent may not use a subagent to conduct money  
 8           transmission on behalf of a licensee.

9           §1055. Unauthorized activities; prohibited activities

10           A. A person shall not engage in the business of money transmission on  
 11           behalf of a person not licensed pursuant to this Chapter or not exempt pursuant to  
 12           R.S. 6:1034 and 1035. A person who engages in such activity provides money  
 13           transmission to the same extent as if the person were a licensee, and shall be jointly  
 14           and severally liable with the unlicensed or nonexempt person.

15           B. A person shall not engage in money transmission pursuant to this Chapter  
 16           if the transmission of money, or its equivalent, is undertaken for the purpose of debt  
 17           adjusting, as defined in R.S. 14:331.

18           C. For the purposes of this Section, money transmission for the purpose of  
 19           debt adjusting includes but is not limited to any activity in which a person, directly  
 20           or indirectly:

21           (1) Acts, or agrees to act, as an agent, processor, custodian, intermediary,  
 22           clearing entity, payment service provider, escrow service, or similar function for a  
 23           debt adjustor or debtor.

24           (2) Receives, holds, distributes, or disburses money, or its equivalent,  
 25           provided by or on behalf of a debtor in connection with debt adjusting.

26           (3) Transmits money, or its equivalent, in the name of, at the direction of, or  
 27           for the benefit of a debt adjustor or a debtor.

28           D. A person shall not avoid or attempt to avoid the prohibition against debt  
 29           adjusting in this Section by using any structure or arrangement, regardless of form,  
 30           including by:

1           (1) Structuring transactions so that the receipt of money, or its equivalent,  
 2           from a debtor and the distribution or disbursement of such money to creditors are  
 3           performed by different persons, whether affiliated or unaffiliated, including where  
 4           a third party receives debtor funds and a person distributes or disburses such funds,  
 5           when such activities are undertaken pursuant to a common plan, arrangement, or  
 6           understanding to accomplish debt adjusting.

7           (2) Characterizing debtor funds as fees, administrative payments, processing  
 8           payments, or any other designation.

9           (3) Transmitting, depositing, or maintaining a debtor's money, or its  
 10          equivalent, into pooled accounts, pass-through accounts, trust accounts, custodial  
 11          accounts, or similar accounts.

12          E. Nothing in this Section shall be construed to prohibit or limit debt  
 13          adjusting activities expressly permitted pursuant to R.S. 14:331(C), including the  
 14          receipt and disbursement of debtor funds to the extent authorized therein. A money  
 15          transmission license shall not be used to authorize, facilitate, or expand debt  
 16          adjusting activities, and a person holding such a license shall remain subject to the  
 17          prohibitions of this Section with respect to any money transmission that is not  
 18          otherwise permitted in accordance with R.S. 14:331(C).

19          §1056. Timely transmission

20          A. Every money transmitter licensee and its agents shall transmit the  
 21          monetary equivalent of all money or equivalent value received from a consumer for  
 22          transmission, net of any fees, or issue instructions committing the money or its  
 23          monetary equivalent, to the person designated by the consumer, or return such  
 24          amount to the consumer, within ten business days after receiving the money or  
 25          equivalent value, unless otherwise ordered by the consumer, accepted pursuant to the  
 26          terms of a contract for stored value or when the transmission is for the payment of  
 27          goods or services, or unless the licensee or its agent has reasonable cause to believe  
 28          that the sender may be a victim of fraud or that a crime or a violation of law has  
 29          occurred, is occurring, or will occur in connection with transmitting the money.

1           B. If a licensee fails to forward money received for transmission in  
2           accordance with this Section, the licensee shall respond to inquiries by the sender  
3           with the reason for the failure unless providing a response would violate a state or  
4           federal law, rule, or regulation.

5           C. For purposes of this Section, money is considered to have been  
6           transmitted when it is mailed, released to the relevant payment system for delivery,  
7           or is otherwise available to the person designated by the consumer and, where  
8           possible, a reasonable effort has been made to inform the designated person that the  
9           money is available.

10           D.(1) Any provision in a money transmitter licensee user policy or user  
11           agreement which provides a financial penalty or stipulated damages against a  
12           consumer or charitable organization as defined by R.S. 51:1901 for executing a  
13           lawful and valid transaction pursuant to federal and state law is contrary to public  
14           policy and shall be null and void.

15           (2) A money transmitter licensee shall provide notice to a consumer of any  
16           transaction that the money transmitter finds to be or is suspected of being in violation  
17           of the user policy or user agreement and for which the licensee seizes the transaction  
18           funds, unless such notice is prohibited by law. Any funds seized by the money  
19           transmitter prior to providing such notice, unless such notice is prohibited by law,  
20           and found to be from a lawful and valid transaction in accordance with federal and  
21           state law shall be processed by the licensee in accordance with Subsection A of this  
22           Section.

23           E. The enforcement of any choice-of-law provision in a money transmitter  
24           licensee user policy or user agreement that would result in a contravention of the  
25           public policy of this state as expressed by Subsection D of this Section shall be null  
26           and void to the extent of such contravention.

27           F. A money transmitter licensee that seizes or holds funds pursuant to a user  
28           policy or user agreement provision that is subject to nullification as provided by this  
29           Section shall return to the consumer any funds held or seized as a result of the

1 violation, including any financial penalty or stipulated damages assessed, and the  
 2 money transmitter licensee may cancel the service contract.

3 G. The commissioner may enjoin a violation of this Chapter, and any such  
 4 violation shall be considered an unfair trade practice and shall subject violators to the  
 5 provisions of the Unfair Trade Practices and Consumer Protection Law, R.S. 51:1401  
 6 et seq. Entities covered by this Section shall be subject to the enforcement powers  
 7 of the commissioner as provided in R.S. 6:121.1. For purposes of this Section, the  
 8 provisions of R.S. 51:1406 shall not apply to a money transmitter licensee.

9 H.(1) The provisions of this Section shall not apply to any federally insured  
 10 depository financial institution, its subsidiaries, or affiliates.

11 (2) The provisions of this Section shall not apply to an operator of a payment  
 12 system or its subsidiaries and affiliates which are exempt from licensing pursuant to  
 13 this Chapter to the extent that the operator of a payment system provides processing,  
 14 clearing, or settlement services, between or among persons, in connection with wire  
 15 transfers, credit card transactions, debit card transactions, stored value transactions,  
 16 automated clearing house transfers, or similar funds transfers.

17 §1057. Refunds

18 A. This Section does not apply to:

19 (1) Money received for transmission subject to the federal Remittance Rule,  
 20 12 CFR Part 1005, Subpart B, as amended or recodified from time to time.

21 (2) Money received for transmission pursuant to a written agreement  
 22 between the licensee and payee to process payments for goods or services provided  
 23 by the payee.

24 B. Every licensee shall refund to the sender within ten calendar days of  
 25 receipt of the sender's written request for a refund of any and all money received for  
 26 transmission unless any of the following applies:

27 (1) The money has been forwarded within ten calendar days of the date on  
 28 which the money was received for transmission.

1           (2) Instructions have been given committing an equivalent amount of money  
 2           to the person designated by the sender within ten calendar days of the date on which  
 3           the money was received for transmission.

4           (3) The agreement between the licensee and the sender instructs the licensee  
 5           to forward the money at a time that is beyond ten calendar days of the date on which  
 6           the money was received for transmission. If funds have not yet been forwarded in  
 7           accordance with the terms of the agreement between the licensee and the sender, the  
 8           licensee shall issue a refund in accordance with the other provisions of this Section.

9           (4) The refund is requested for a transaction that the licensee has not  
 10          completed based on a reasonable belief or a reasonable basis to believe that a crime  
 11          or violation of law, rule, or regulation has occurred, is occurring, or may occur.

12          (5) The refund request does not enable the licensee to:

13          (a) Identify the sender's name and address or telephone number.

14          (b) Identify the particular transaction to be refunded in the event the sender  
 15          has multiple transactions outstanding.

16          §1058. Receipts

17          A. This Section does not apply to any of the following:

18          (1) Money received for transmission subject to the federal Remittance Rule,  
 19          12 CFR Part 1005, Subpart B, as amended or recodified from time to time.

20          (2) Money received for transmission that is not primarily for personal,  
 21          family, or household purposes.

22          (3) Money received for transmission pursuant to a written agreement  
 23          between the licensee and payee to process payments for goods or services provided  
 24          by the payee.

25          B. For a transaction conducted in person, the receipt may be provided  
 26          electronically if the sender requests or agrees to receive an electronic receipt. For  
 27          a transaction conducted electronically or by phone, a receipt may be provided  
 28          electronically. All electronic receipts shall be provided in a retainable form.

29          C. Every licensee or its authorized agent shall provide the sender with a  
 30          receipt for money received for transmission.

1                   (1) The receipt shall contain all of the following information, as applicable:

2                   (a) The name of the sender.

3                   (b) The name of the designated recipient.

4                   (c) The date of the transaction.

5                   (d) The unique transaction or identification number.

6                   (e) The name of the licensee, NMLS Unique ID, the licensee's business  
7 address, and the licensee's customer service telephone number.

8                   (f) The amount of the transaction in United States dollars.

9                   (g) Any fee charged by the licensee to the sender for the transaction.

10                  (h) Any taxes collected by the licensee from the sender for the transaction.

11                  (2) The receipt required by this Section shall be in English and in the  
12 language principally used by the licensee or authorized agent to advertise, solicit, or  
13 negotiate, either orally or in writing, for a transaction conducted in person,  
14 electronically, or by phone, if other than English.

15                  §1059. Required maintenance of tangible net worth

16                   A. A licensee pursuant to this Chapter shall maintain at all times a tangible  
17 net worth of the greater of one hundred thousand dollars or three percent of total  
18 assets for the first one hundred million dollars, two percent of additional assets for  
19 one hundred million dollars to one billion dollars, and one-half percent of additional  
20 assets for over one billion dollars.

21                   B. Tangible net worth shall be demonstrated at initial application by the  
22 applicant's most recent audited statements pursuant to R.S. 6:1041(B)(6).

23                   C. All licensing requirements, including renewals, relative to tangible net  
24 worth shall be evidenced at the time of initial application for licensure and renewal,  
25 maintained at all times during licensure and renewal, and reported annually to the  
26 commissioner in accordance with R.S. 6:1044 (B)(3).

27                  §1060. Surety bond

28                   A. An applicant for a money transmission license shall provide, and a  
29 licensee at all times shall maintain, a surety bond issued by a bonding company or

1 insurance company authorized to do business in this state and in a form satisfactory  
2 to the commissioner.

3 B.(1) The amount of the required surety bond shall be the greater of the  
4 following:

5 (a) One hundred thousand dollars.

6 (b) An amount equal to one hundred percent of the licensee's average daily  
7 money transmission liability in this state calculated for the most recently completed  
8 three-month period, up to a maximum of five hundred thousand dollars.

9 (2) A licensee that maintains a bond in the maximum amount provided for  
10 in Subparagraphs (1)(a) or (b) of this Subsection, as applicable, shall not be required  
11 to calculate its average daily money transmission liability in this state for purposes  
12 of this Section.

13 C. A licensee may exceed the maximum required bond amount pursuant to  
14 R.S. 6:1062(G).

15 D. The bond shall be in a form satisfactory to the commissioner and shall be  
16 for the use and benefit of the office and any claimants against the licensee or his  
17 agents to secure the faithful performance of the obligations of the licensee and his  
18 agents with respect to the receipt, handling, transmission, and payment of money in  
19 connection with money transmissions in this state.

20 E. The surety bond shall be issued by a bonding or insurance company  
21 authorized to do business in this state and in a form satisfactory to the commissioner  
22 and payable to the office for the benefit of any claimant against the licensee to secure  
23 the faithful performance of the obligations and duties of the licensee with respect to  
24 money transmission activities with, or on behalf of, residents of this state and the  
25 payment of required but unpaid fee amounts due to the office and assessed but  
26 unpaid civil money penalties.

27 F. Any claimants against the licensee or his agents may themselves bring suit  
28 directly on the bond, or the attorney general may bring suit on behalf of those  
29 claimants, either in one action or successive actions.

1           G. The commissioner may increase the required amount of the bond upon  
2           the basis of the impaired financial condition of a licensee as evidenced by a reduction  
3           in net worth, financial losses, or other relevant criteria.

4           H. Notwithstanding any other provision of law to the contrary, the  
5           commissioner may at any time, if in the commissioner's sole opinion the protection  
6           of the public so requires, increase the principal sum of the bond required of any  
7           applicant or licensee by this Chapter but in no case shall the principal sum of the  
8           bond required exceed one million dollars.

9           §1061. Maintenance of permissible investments

10           A. A licensee shall maintain at all times permissible investments that have  
11           a market value computed in accordance with United States Generally Accepted  
12           Accounting Principles of not less than the aggregate amount of all of its outstanding  
13           money transmission obligations in all states.

14           B. Except for permissible investments enumerated in R.S. 6:1062(A), the  
15           commissioner, with respect to any licensee, may by rule, regulation, or order limit  
16           the extent to which a specific investment maintained by a licensee within a class of  
17           permissible investments may be considered a permissible investment, if the specific  
18           investment represents undue risk to customers, not reflected in the market value of  
19           investments.

20           C. Permissible investments, even if commingled with other assets of the  
21           licensee, are held in trust for the benefit of the purchasers and holders of the  
22           licensee's outstanding money transmission obligations in the event of insolvency, the  
23           filing of a petition by or against the licensee in accordance with the United States  
24           Bankruptcy Code, 11 U.S.C. 101 through 110, both inclusive, as amended or  
25           recodified from time to time, for bankruptcy or reorganization, the filing of a petition  
26           by or against the licensee for receivership, the commencement of any other judicial  
27           or administrative proceeding for its dissolution or reorganization, or in the event of  
28           an action by a creditor against the licensee who is not a beneficiary of this statutory  
29           trust. No permissible investments impressed with a trust pursuant to this Subsection

1           shall be subject to attachment, levy of execution, or sequestration by order of any  
 2           court, except for a beneficiary of this statutory trust.

3           D.(1) Upon the establishment of a statutory trust in accordance with  
 4           Subsection C of this Section or when any funds are drawn on a letter of credit  
 5           pursuant to R.S. 6:1062(B), the commissioner shall notify the applicable regulator  
 6           of each state in which the licensee is licensed to engage in money transmission, if  
 7           any, of the establishment of the trust or the funds drawn on the letter of credit, as  
 8           applicable.

9           (2) Notice shall be deemed satisfied if performed pursuant to a multistate  
 10          agreement or through NMLS.

11          (3) Funds drawn on a letter of credit, and any other permissible investments  
 12          held in trust for the benefit of the purchasers and holders of the licensee's outstanding  
 13          money transmission obligations, are deemed held in trust for the benefit of such  
 14          purchasers and holders on a pro rata and equitable basis in accordance with statutes  
 15          pursuant to which permissible investments are required to be held in this state, and  
 16          other states, as applicable.

17          (4) Any statutory trust established pursuant to this Subsection shall be  
 18          terminated upon extinguishment of all of the licensee's outstanding money  
 19          transmission obligations.

20          E. The commissioner, by rule, regulation, or by order may allow other types  
 21          of investments that the commissioner determines are of sufficient liquidity and  
 22          quality to be a permissible investment. The commissioner may participate in efforts  
 23          with other state regulators to determine that other types of investments are of  
 24          sufficient liquidity and quality to be a permissible investment.

25          §1062. Types of permissible investments

26          A. The following investments are permissible in accordance with R.S.  
 27          6:1061:

28          (1) Cash, including demand deposits, savings deposits, and funds in such  
 29          accounts held for the benefit of the licensee's customers in a federally insured  
 30          depository financial institution, and cash equivalents including Automated Clearing

1 House, or ACH, items in transit to the licensee and ACH items or international wires  
 2 in transit to a payee, cash in transit via armored car, cash in smart safes, cash in  
 3 licensee-owned locations, debit card or credit card-funded transmission receivables  
 4 owed by any bank, or money market mutual funds rated "AAA" by Standard &  
 5 Poors, or the equivalent from any eligible rating service.

6 (2) Certificates of deposit or senior debt obligations of an insured depository  
 7 institution, as defined in Section 3 of the Federal Deposit Insurance Act, 12 U.S.C.  
 8 1813, as amended or recodified from time to time, or as defined in accordance with  
 9 the Federal Credit Union Act, 12 U.S.C. 1751, as amended or recodified from time  
 10 to time.

11 (3) An obligation of the United States or a commission, agency, or  
 12 instrumentality thereof, an obligation that is guaranteed fully as to principal and  
 13 interest by the United States, or an obligation of a state or a governmental  
 14 subdivision, agency, or instrumentality thereof.

15 B. The permissible investments listed in Subsection A of this Section shall  
 16 also include the full drawable amount of an irrevocable standby letter of credit for  
 17 which the stated beneficiary is the commissioner that stipulates that the beneficiary  
 18 need only draw a sight draft under the letter of credit and present it to obtain funds  
 19 up to the letter of credit amount within seven calendar days of presentation of the  
 20 items required by Subsection D of this Section. The letter of credit shall meet all of  
 21 the following requirements:

22 (1) Be issued by a federally insured depository financial institution, a foreign  
 23 bank that is authorized pursuant to federal law to maintain a federal agency or federal  
 24 branch office in a state or states, or a foreign bank that is authorized pursuant to state  
 25 law to maintain a branch in a state that do both of the following:

26 (a) Bears an eligible rating or whose parent company bears an eligible rating.

27 (b) Is regulated, supervised, and examined by United States federal or state  
 28 authorities having regulatory authority over banks, credit unions, and trust  
 29 companies.

1           (2) Be irrevocable, unconditional, and indicate that it is not subject to any  
2           condition or qualifications outside of the letter of credit.

3           (3) Not contain reference to any other agreements, documents, or entities,  
4           or otherwise provide for any security interest in the licensee.

5           (4) Contain an issue date and expiration date, and expressly provide for  
6           automatic extension, without a written amendment, for an additional period of one  
7           year from the present or each future expiration date, unless the issuer of the letter of  
8           credit notifies the commissioner in writing by certified or registered mail or courier  
9           mail or other receipted means, at least sixty calendar days prior to any expiration  
10          date, that the irrevocable letter of credit will not be extended.

11          C. In the event of any notice of expiration or nonextension of a letter of  
12          credit issued pursuant to Paragraph (B)(4) of this Section, the licensee shall be  
13          required to demonstrate to the satisfaction of the commissioner, fifteen calendar days  
14          prior to expiration, that the licensee maintains and will maintain permissible  
15          investments in accordance with R.S. 6:1061(A) upon the expiration of the letter of  
16          credit. If the licensee is not able to do so, the commissioner may draw on the letter  
17          of credit in an amount up to the amount necessary to meet the licensee's requirements  
18          to maintain permissible investments in accordance with R.S. 6:1061(A). Any such  
19          draw shall be offset against the licensee's outstanding money transmission  
20          obligations. The drawn funds shall be held in trust by the commissioner or the  
21          commissioner's designated agent, to the extent authorized by law, as agent for the  
22          benefit of the purchasers and holders of the licensee's outstanding money  
23          transmission obligations.

24          D. The letter of credit shall provide that the issuer of the letter of credit will  
25          honor, at sight, a presentation made by the beneficiary to the issuer of the following  
26          documents on or prior to the expiration date of the letter of credit:

27               (1) The original letter of credit, including any amendments.

28               (2) A written statement from the beneficiary stating if any of the following  
29               events have occurred:

1           (a) The filing of a petition by or against the licensee in accordance with the  
 2           United States Bankruptcy Code, 11 U.S.C. 101 through 110, both inclusive, as  
 3           amended or recodified from time to time, for bankruptcy or reorganization.

4           (b) The filing of a petition by or against the licensee for receivership, or the  
 5           commencement of any other judicial or administrative proceeding for its dissolution  
 6           or reorganization.

7           (c) The seizure of assets of a licensee by a commissioner pursuant to an  
 8           emergency order issued in accordance with applicable law, on the basis of an action,  
 9           violation, or condition that has caused or is likely to cause the insolvency of the  
 10          licensee.

11          (d) The beneficiary has received notice of expiration or nonextension of a  
 12          letter of credit and the licensee failed to demonstrate to the satisfaction of the  
 13          beneficiary that the licensee will maintain permissible investments in accordance  
 14          with R.S. 6:1061(A) upon the expiration or nonextension of the letter of credit.

15          E. The commissioner may designate an agent to serve on the commissioner's  
 16          behalf as beneficiary to a letter of credit so long as the agent and letter of credit meet  
 17          requirements established by the commissioner. The commissioner's agent may serve  
 18          as agent for multiple licensing authorities for a single irrevocable letter of credit if  
 19          the proceeds of the drawable amount for the purposes of this Subsection are assigned  
 20          to the commissioner.

21          F. The commissioner may participate in multistate processes designed to  
 22          facilitate the issuance and administration of letters of credit, including but not limited  
 23          to services provided by the NMLS and State Regulatory Registry, LLC.

24          G. The permissible investments listed in Subsection A of the Section shall  
 25          also include:

26                 (1) One hundred percent of the surety bond provided for in accordance with  
 27                 R.S. 6:1060 that exceeds the average daily money transmission liability in this state.

28                 (2) Any other investment approved by the commissioner.

1           H. Unless permitted by the commissioner by rule, regulation, or by order to  
2           exceed the limit as set forth herein, the following investments are permissible  
3           pursuant to R.S. 6:1062 to the extent specified:

4           (1) Receivables that are payable to a licensee from its authorized agents in  
5           the ordinary course of business that are aged less than seven calendar days from their  
6           issuance date, up to fifty percent of the aggregate value of the licensee's total  
7           permissible investments.

8           (2) Of the receivables permissible pursuant to Paragraph (1) of this  
9           Subsection, receivables that are payable to a licensee from a single authorized agent  
10          in the ordinary course of business may not exceed ten percent of the aggregate value  
11          of the licensee's total permissible investments.

12          (3) The following investments are permissible up to twenty percent per  
13          category and combined up to fifty percent of the aggregate value of the licensee's  
14          total permissible investments:

15           (a) A short-term, up to six months, investment bearing an eligible rating.

16           (b) Commercial paper bearing an eligible rating.

17           (c) A bill, note, bond, or debenture bearing an eligible rating.

18           (d) United States tri-party repurchase agreements collateralized at one  
19           hundred percent or more with United States government or agency securities,  
20           municipal bonds, or other securities bearing an eligible rating.

21           (e) Money market mutual funds rated less than "AAA" and equal to or higher  
22           than "A-" by Standard & Poors, or the equivalent from any other eligible rating  
23           service.

24           (f) A mutual fund or other investment fund composed solely and exclusively  
25           of one or more permissible investments listed in Subsection A of this Section.

26          I. Cash, including demand deposits, savings deposits, and funds in such  
27          accounts held for the benefit of the licensee's customers, at foreign depository  
28          institutions are permissible up to ten percent of the aggregate value of the licensee's  
29          total permissible investments if the licensee has received a satisfactory rating in its

1 most recent examination and the foreign depository institution meets all of the  
 2 following requirements:

3 (1) Has an eligible rating.

4 (2) Is registered pursuant to the United States Foreign Account Tax  
 5 Compliance Act.

6 (3) Is not located in any country subject to sanctions from the United States  
 7 Office of Foreign Asset Control.

8 (4) Is not located in a high-risk or noncooperative jurisdiction as designated  
 9 by the International Financial Action Task Force.

10 §1063. Suspension and revocation

11 A. The commissioner may suspend or revoke a license or order a licensee  
 12 to revoke the designation of an authorized agent if any of the following occur:

13 (1) The licensee violates any provision of this Chapter or a rule adopted or  
 14 regulation promulgated or order issued pursuant thereto.

15 (2) The licensee does not cooperate with an examination or investigation by  
 16 the commissioner.

17 (3) The licensee engages in fraud, intentional misrepresentation, or gross  
 18 negligence.

19 (4) An authorized agent is convicted of a violation of a state or federal  
 20 anti-money laundering statute, or violates any rule, regulation, or order related to the  
 21 provisions of this Chapter, as a result of the licensee's gross negligence, willful  
 22 misconduct, or willful blindness.

23 (5) The competence, experience, character, or general fitness of the licensee,  
 24 authorized agent, person in control of a licensee, key individual, or responsible  
 25 person of the authorized agent indicates that it is not in the public interest to permit  
 26 the person to provide money transmission.

27 (6) The licensee engages in an unsafe or unsound practice.

28 (7) The licensee is insolvent, suspends payment of its obligations, or makes  
 29 a general assignment for the benefit of its creditors.

1                   (8) The licensee does not remove an authorized agent after the commissioner  
 2                   issues and serves upon the licensee a final order including a finding that the  
 3                   authorized agent has violated one or more provisions of this Chapter.

4                   B. In determining whether a licensee is engaging in an unsafe or unsound  
 5                   practice, the commissioner may consider the size and condition of the licensee's  
 6                   money transmission, the magnitude of the loss, the gravity of the violation of this  
 7                   Chapter, and the previous conduct of the person involved.

8                   §1064. Violations

9                   A. The office may implement an enforcement action against a licensee or  
 10                   person who is not a licensee but is engaging in money transmission activities with,  
 11                   or on behalf of, a resident in any of the following instances:

12                   (1) The licensee or person violates any of the provisions of this Chapter or  
 13                   any rule or regulation promulgated or any order, including but not limited to a cease  
 14                   and desist order or subpoena, issued pursuant to this Chapter.

15                   (2) The licensee or person violates any provision of a voluntary consent or  
 16                   compliance agreement that has been entered into with the commissioner.

17                   (3) The licensee or person, in the conduct of its money transmission  
 18                   activities with, or on behalf of, a resident, engages in any of the following:

19                   (a) An unsafe or unsound act or practice.

20                   (b) An unfair or deceptive act or practice.

21                   (c) Fraud or intentional misrepresentation.

22                   (d) Any other dishonest act.

23                   (e) Misappropriation of money, or its equivalent having monetary value, held  
 24                   by a fiduciary.

25                   (4) The licensee or person does not cooperate substantially with an  
 26                   investigation by the office, fails to pay a fee, or fails to submit a report or  
 27                   documentation.

28                   (5) If any of the following occurs:

29                   (a) The licensee or person becomes insolvent.

1                   **(b) The licensee or person makes a general assignment for the benefit of its**  
2                   **creditors.**

3                   **(c) The licensee or person becomes the debtor, alleged debtor, respondent,**  
4                   **or person in a similar capacity in a case or other proceeding under any bankruptcy,**  
5                   **reorganization, arrangement, readjustment, insolvency, receivership, dissolution,**  
6                   **liquidation, or similar law and does not obtain from the court, within a reasonable**  
7                   **time, confirmation of a plan or dismissal of the case or proceeding.**

8                   **(d) The licensee or person applies for, or permits the appointment of, a**  
9                   **receiver, trustee, or other agent of a court for itself or for a substantial part of its**  
10                   **assets.**

11                   **(6) The licensee or person has knowingly provided or caused to be provided**  
12                   **a material misrepresentation to the commissioner, any false or fraudulent material**  
13                   **fact, or any false or fraudulent financial statement or has suppressed or withheld**  
14                   **from the commissioner any information which if submitted by the licensee would**  
15                   **have resulted in a denial of the license application.**

16                   **(7) The licensee or person refuses to permit an examination by the**  
17                   **commissioner of the books and affairs or has refused or failed within a reasonable**  
18                   **time to furnish any information or make any report that may be required by the**  
19                   **commissioner pursuant to the provisions of this Chapter.**

20                   **(8) The licensee or person fails to maintain records as required by the**  
21                   **commissioner after being given written notice to the last address of record and thirty**  
22                   **calendar days within which to correct the failure. The commissioner may grant up**  
23                   **to two thirty-calendar-day extensions within which to correct the recordkeeping**  
24                   **violation.**

25                   **(9) The licensee or person who continues to have in office any individual**  
26                   **with power to direct the management or policies of a person regulated by this**  
27                   **Chapter including but not limited to any officer, director, or manager, if such**  
28                   **individual is convicted of, pleads guilty to, or is found guilty after a plea of nolo**  
29                   **contendere of any felony and has been adjudicated guilty in any state, federal,**  
30                   **foreign, or military court.**

1           (10) The licensee or person violates any provision of a regulatory or  
2           prohibitory statute of this state or any other state as determined by the government  
3           agency responsible for citing such violations.

4           (11) The licensee or person misrepresents material facts or makes a false  
5           promise likely to influence, persuade, or induce a resident to engage in money  
6           transmission activities.

7           (12) The licensee or person misrepresents or conceals a material fact, term,  
8           or condition of a transaction to which he is a party pertinent to a resident to engage  
9           in money transmission activities.

10          (13) The licensee or person knowingly engages in any transaction, practice,  
11          or course of business which perpetrates a fraud upon any person in connection with  
12          engaging in money transmission activities.

13          (14) The licensee or person fails to sell, transfer, receive, or store, without  
14          just cause, any funds in accordance with any agreement connected with a money  
15          transmission transaction.

16          (15) The licensee or person fails to account for or deliver to any person any  
17          assets obtained in connection with a money transmission activity transaction  
18          including but not limited to money or its equivalent having monetary value.

19          (16) The licensee or person fails to pay any fee, civil money penalty, cost,  
20          or assessment imposed pursuant to this Chapter or by any rule adopted or regulation  
21          promulgated in accordance with this Chapter.

22          (17) The licensee or person violates the written restrictions or conditions  
23          under which the license was issued.

24          (18) The licensee or person fails, after notice and without lawful excuse, to  
25          obey any order or subpoena issued by the commissioner.

26          (19) The commissioner discovers any fact or condition that currently exists  
27          that, if it had existed at the time of the original application for licensure, would have  
28          warranted the denial of the application.

29          B.(1) Notwithstanding any other law to the contrary, and in addition to any  
30          other authority conferred upon the commissioner by any other provision of law, the

1 commissioner may, upon discovery, order an immediate suspension of the license  
2 of any person licensed pursuant to this Chapter who does any of the following:

3 (a) Fails to meet the tangible net worth or fails to maintain the surety bond  
4 requirements in any manner as provided for pursuant to R.S. 6:1059 or 1060.

5 (b) Commits a violation of any provision of this Chapter such that, in the  
6 opinion of the commissioner, public safety and welfare demand that emergency  
7 action be taken.

8 (c) Submits a payment of any fee for any application, notification,  
9 examination, investigation, late fee, or penalty that is returned, declined, denied, or  
10 otherwise not paid in full for any reason.

11 (d) Is convicted of a felony that would have prohibited the issuance or  
12 renewal of the license.

13 (e) Has his license to engage in money transmission activities suspended or  
14 revoked in another jurisdiction.

15 (2) A person whose license is suspended pursuant to this Subsection shall  
16 have thirty calendar days from the date of the order to request a hearing in  
17 accordance with the Administrative Procedure Act. Failure to timely request a  
18 hearing shall constitute a waiver of all hearing rights regarding the suspension.

19 C. In addition to any other authority conferred upon the commissioner by  
20 this Chapter or this Title, the commissioner may issue a cease and desist order, order  
21 refunds of any unauthorized portion of any fee, or charge any person who collects  
22 in violation of this Chapter and may impose a civil money penalty as determined by  
23 the commissioner by rule upon any person who is found to have violated any of the  
24 provisions of this Chapter or any rule or regulation promulgated in accordance with  
25 this Chapter. Each separate violation shall subject the person to a civil money  
26 penalty, and each day the person acts without complying with the provisions of this  
27 Chapter, or rules or regulations promulgated in accordance with this Chapter, shall  
28 constitute a separate violation.

29 D. The violations listed in this Subsection are nonexclusive and are in  
30 addition to and exist independent of any violations set forth in other provisions of

1 this Chapter. Failure to comply with any provisions set forth in this Chapter may  
2 serve as a basis for any enforcement or other action authorized to the commissioner  
3 pursuant to this Title. It shall be a violation of this Chapter for a person engaged in  
4 money transmission activities pursuant to this Chapter to do any of the following:

5 (1) Directly or indirectly employ any scheme, device, or artifice to defraud  
6 or mislead any resident, when such person knew or should have known that such  
7 scheme, device, or artifice was defrauding or misleading.

8 (2) Engage in any unfair or deceptive practice toward any resident.

9 (3) Fail to comply with this Chapter, any rules or regulations promulgated  
10 pursuant to this Chapter, the laws of this state, or federal law, including the rules and  
11 regulations issued thereunder, applicable to any money transmission activities.

12 (4) Negligently make any false statement, or knowingly and willfully make  
13 any omission of material fact, in connection with any information or reports filed  
14 with a state or federal government agency or the NMLS or in connection with any  
15 investigation conducted by the commissioner or any other state or federal  
16 government agency.

17 (5) Fail to truthfully account for any assets in connection with any money  
18 transmission activities with, or on behalf of, a resident.

19 E. The commissioner may report apparent violations to other appropriate  
20 state and federal regulators, the NMLS, federal law enforcement agencies, the  
21 attorney general, or the district attorney of the appropriate parish, who may institute  
22 any proceeding as he considers appropriate.

23 F. Advisory opinions and interpretations of the office shall not be considered  
24 rules requiring compliance with the rulemaking process of the Administrative  
25 Procedure Act. The commissioner and the employees of the office shall have no  
26 liability to any person with respect to an advisory opinion or interpretation issued in  
27 connection with this Chapter.

28 G. All of the grounds for enforcement action listed in Subsections A and D  
29 of this Section are violations of this Chapter and may serve as the basis for any other  
30 enforcement action provided to the commissioner by this Title.

1           H. The commissioner may share information about any person who is  
2           licensed or required to be licensed pursuant to this Chapter with any state or federal  
3           agency also having jurisdiction over the money transmission activities of that person.

4           I.(1) Any licensee whose license was issued pursuant to this Chapter and has  
5           been revoked for any reason may not reapply for a license until at least five years  
6           have elapsed from the date of the order of revocation, unless the commissioner, in  
7           his sole discretion, prescribes an earlier or later date.

8           (2) For purposes of this Subsection, the order is considered to be the  
9           commissioner's notification of revocation of the license.

10          (3) For the purpose of this Subsection, the term "licensee" shall include the  
11          licensee, owners of ten percent or more of the licensee, and its members if the  
12          licensee is a limited liability company, its partners if the licensee is a partnership, its  
13          officers and directors if the licensee is a corporation, and any other person  
14          determined by the commissioner, in his sole discretion, to be closely related to the  
15          licensee.

16          §1065. Authorized agents; suspend or revoke designation; grounds; relief

17          A. The commissioner may issue an order suspending or revoking the  
18          designation of an authorized agent if the commissioner finds that any of the  
19          following apply:

20          (1) The authorized agent violated any provision of this Chapter or a rule,  
21          regulation, or order promulgated or issued pursuant to this Chapter.

22          (2) The authorized agent did not cooperate with an examination or  
23          investigation by the commissioner.

24          (3) The authorized agent engaged in fraud, intentional misrepresentation, or  
25          gross negligence.

26          (4) The authorized agent is convicted of a violation of a state or federal  
27          anti-money-laundering statute.

28          (5) The competence, experience, character, or general fitness of the  
29          authorized agent or a person in control of the authorized agent indicates that it is not  
30          in the public interest to permit the authorized agent to provide money transmission.

1           (6) The authorized agent is engaging in an unsafe or unsound practice.

2           B. In determining whether an authorized agent is engaging in an unsafe or  
3           unsound practice, the commissioner may consider the size and condition of the  
4           authorized agent's provision of money transmission, the magnitude of the loss, the  
5           gravity of the violation of this Chapter or a rule or regulation adopted and  
6           promulgated or order issued in accordance with this Chapter, and the previous  
7           conduct of the authorized agent.

8           C. An authorized agent may apply for relief from a suspension or revocation  
9           of designation as an authorized agent according to procedures prescribed by the  
10           commissioner.

11           §1066. Notice and license revocation hearing

12           A. A license shall not be revoked except on ten calendar days' notice, the  
13           first day of the ten-day period to be the date stated on the notice, which shall be the  
14           day it is mailed, to the licensee by the commissioner, sent by letter by United States  
15           registered or certified mail, return receipt requested, to the licensee's business  
16           address set forth in the application.

17           B. Upon receipt of the notice, as stated in the registered or certified mail  
18           receipt, the licensee may, within five calendar days thereafter, which five-day period  
19           may be wholly or partially outside of the ten-day period, make written demand for  
20           a hearing by the office, which demand shall be accompanied by an additional surety  
21           bond, the principal sum, or the market value thereof to be specified by the  
22           commissioner in the revocation notice.

23           C. The revocation notice shall not become final during the period of time in  
24           which the licensee may demand such hearing nor if licensee demands a hearing, until  
25           the matter has been finally determined by the office or by the courts, provided that  
26           the licensee first posts together with his written demand for hearing an additional  
27           corporate surety bond, written by the same bonding or insurance company that wrote  
28           the bond required pursuant to R.S. 6:1060 made by the licensee pursuant to R.S.  
29           6:1060 which the additional surety bond shall be in a principal amount as specified  
30           in the revocation order but not exceeding one million dollars. The bond shall secure

1           the same obligations as does the corporate surety bond required by R.S. 6:1060 but  
2           shall be in addition to the bond required thereby.

3           D. Upon receipt of the written demand, the commissioner shall thereafter,  
4           with reasonable promptness, hear and determine the matter as provided by law or  
5           regulation.

6           E. If the licensee deems himself aggrieved by the determination or order of  
7           the commissioner, he may within thirty calendar days after the determination or  
8           order have the determination or order reviewed by an appeal. All appeals shall be in  
9           accordance with the Administrative Procedure Act. The appeal shall be perfected  
10          upon the posting of a bond for the costs of the appeal accompanied by the petition.

11          F. Final revocation of the license, whether automatic or by final  
12          determination of the commissioner or the courts, shall cancel as of the date of final  
13          revocation of all bonds theretofore furnished by the licensee in accordance with any  
14          provision of this Section, provided that the licensee and his corporate surety shall not  
15          be relieved of any accrued liabilities, until the commissioner determines that all  
16          accrued liabilities, including but not limited to the principal sums thereof, accrued  
17          interest thereon, and court costs, if any, assessed to the licensee, of the licensee  
18          pursuant to this Section have been satisfied in full.

19          G. The commissioner may at any time revoke a license on any ground on  
20          which he might refuse to grant a license, or for failure to pay an annual fee, or for  
21          violation of any provision of this Section, and any such revocation shall be  
22          implemented in accordance with the provisions of this Section.

23          H. A license shall be automatically and finally revoked without any act or  
24          further act of the commissioner in the following instances:

25                 (1) At expiration of the thirty-day notice period, if the corporate surety gives  
26                 notice of cancellation of its bond and failure by the licensee to furnish a replacement  
27                 corporate surety bond or any additional corporate surety bond required by the  
28                 commissioner pursuant to R.S. 6:1060.

1                   (2) Upon failure by the licensee to file when due, following proper notice  
 2                   and a reasonable time period to correct the deficiency, any information required by  
 3                   this Chapter.

4                   (3) In case of a revocation notice pursuant to Subsection A of this Section,  
 5                   failure by the licensee to demand a hearing as provided therein or failure to furnish  
 6                   any additional corporate surety bond as required by the commissioner.

7                   (4) Upon a license revocation order becoming final at any stage.

8                   (5) Upon final conviction of the licensee as to any offense covered by this  
 9                   Chapter.

10                  I. If a revocation order becomes final for any reason or in any manner, the  
 11                  license may not be reinstated, except upon new application as if the licensee had  
 12                  never been licensed before. The commissioner may deny the new application on  
 13                  grounds that a previous application was denied, a previous license to the applicant  
 14                  was revoked, or any ground or grounds on which he may deny an original  
 15                  application.

16                  §1067. Order to cease and desist

17                  A. If the commissioner determines that a violation of this Chapter or of a rule  
 18                  or regulation adopted or an order issued relative thereto by a licensee or authorized  
 19                  agent is likely to cause immediate and irreparable harm to the licensee, its customers,  
 20                  or the public as a result of the violation, or cause insolvency or significant dissipation  
 21                  of assets of the licensee, the commissioner may issue an order requiring the licensee  
 22                  or authorized agent to cease and desist from the violation. The order becomes  
 23                  effective upon service of it upon the licensee or authorized agent.

24                  B. When the commissioner has reasonable cause to believe that a person is  
 25                  violating any provision of this Chapter, the commissioner, in addition to and without  
 26                  prejudice to the authority provided elsewhere in this Chapter, may sue in the  
 27                  Nineteenth Judicial District Court of East Baton Rouge Parish to enjoin the person  
 28                  from engaging in or continuing the violation or from doing any act in furtherance of  
 29                  the violation. In such an action, the court may enter any order or judgment awarding  
 30                  a preliminary or permanent injunction.

1                    C. An order to cease and desist remains effective until rescinded or released  
 2                    by the commissioner or appealed as provided in this Section.

3                    D. A licensee that is served with an order to cease and desist may petition  
 4                    the Nineteenth Judicial District Court of East Baton Rouge Parish for a judicial order  
 5                    setting aside, limiting, or suspending the enforcement, operation, or effectiveness of  
 6                    the order.

7                    §1068. Consent orders

8                    The commissioner may enter into a consent order at any time with a person  
 9                    to resolve a matter arising pursuant to this Chapter or a rule or regulation adopted or  
 10                   order issued relative thereto. A consent order shall be signed by the person to whom  
 11                   it is issued or by the person's authorized representative, and shall indicate agreement  
 12                   with the terms contained in the order. A consent order may provide that it does not  
 13                   constitute an admission by a person that this Chapter or a rule or regulation adopted  
 14                   or an order issued relative thereto has been violated.

15                   §1069. Criminal penalties

16                   A. A person who intentionally makes a false statement, misrepresentation,  
 17                   or false certification in a record filed or required to be maintained pursuant to this  
 18                   Chapter or that intentionally makes a false entry or omits a material entry in such a  
 19                   record is guilty of a felony and, upon conviction thereof, shall be fined not less than  
 20                   five hundred dollars nor more than three thousand dollars, and may also be punished  
 21                   by incarceration for a term not less than one year and not more than five years.

22                   B. A person that knowingly engages in an activity for which a license is  
 23                   required pursuant to this Chapter without being issued such a license and who  
 24                   receives more than five hundred dollars in compensation within a thirty-day period  
 25                   from this activity is guilty of a felony and, upon conviction thereof, shall be fined not  
 26                   less than five hundred dollars nor more than three thousand dollars, and may also be  
 27                   punished by incarceration for a term not less than one year and not more than five  
 28                   years.

29                   C. A person that knowingly engages in an activity for which a license is  
 30                   required pursuant to this Chapter without being issued such a license and who

1 receives no more than five hundred dollars in compensation within a thirty-day  
 2 period from this activity is guilty of a misdemeanor and, upon conviction, shall be  
 3 fined not less than one hundred dollars nor more than five hundred dollars and may  
 4 also be punished by incarceration for a term not more than one year.

5 §1070. Civil money penalties

6 The commissioner may assess a civil money penalty against a person that  
 7 violates any provision of this Chapter or a rule or regulation adopted or an order  
 8 issued relative thereto in an amount not to exceed one thousand dollars per day for  
 9 each day the violation is outstanding, plus this state's costs and expenses for the  
 10 investigation and prosecution of the matter, including reasonable attorney's fees.

11 §1071. Unlicensed persons

12 A.(1) If the commissioner has reason to believe that a person has violated or  
 13 is violating the provisions of R.S. 6:1039, the commissioner may issue an order to  
 14 show cause why an order to cease and desist should not be issued requiring that the  
 15 person cease and desist from the violation of R.S. 6:1039.

16 (2) An order to cease and desist becomes effective upon service of it upon  
 17 the person.

18 (3) An order to cease and desist remains effective and enforceable until  
 19 rescinded or released by the commissioner or appealed as provided in this Section.

20 (4) A person that is served with an order to cease and desist for violating  
 21 R.S. 6:1039 may petition the Nineteenth Judicial District Court of East Baton Rouge  
 22 Parish for a judicial order setting aside, limiting, or suspending the enforcement,  
 23 operation, or effectiveness of the order.

24 B. In an emergency, the commissioner may petition the Nineteenth Judicial  
 25 District Court of East Baton Rouge Parish on an ex parte basis for the issuance of a  
 26 temporary restraining order pursuant to the Louisiana Code of Civil Procedure, and  
 27 such order, if issued, shall not require the posting of a bond on behalf of the state.

28 §1072. Investigation of possible violations

29 In addition to and without prejudice to the authority provided elsewhere in  
 30 this Title, the commissioner, or his duly authorized representative, for the purpose

1           of discovering violations of this Chapter and for the purpose of determining whether  
2           persons are subject to the provisions of this Chapter, may examine persons licensed  
3           pursuant to this Chapter and persons reasonably suspected by the commissioner of  
4           conducting business that requires a license pursuant to this Chapter, including all  
5           relevant books, records, and papers employed by those persons in the transaction of  
6           their business, and may summon witnesses and examine them under oath concerning  
7           matters relating to the business of those persons, or such other matters as may be  
8           relevant to the discovery of violations of this Chapter, including without limitation  
9           the conduct of business without a license as required pursuant to this Chapter.

10           Section 3.(A) A person licensed in this state to engage in the business of money  
11 transmission shall not be subject to the provisions of this Act, to the extent that they conflict  
12 with or establish new requirements not imposed under law as it existed immediately prior  
13 to the effective date of this Act, until such time as the licensee renews its current license or  
14 for twelve months after the effective date of this Act, whichever is later.

15           (B) Notwithstanding Subsection (A) of this Section, a licensee shall only be required  
16 to amend its authorized agent contracts for contracts entered into or amended after the  
17 effective date or the completion of any transition period set forth in Subsection (A) of this  
18 Section. Nothing herein shall be construed as limiting an authorized agent's obligations to  
19 operate in full compliance with this Act as required by R.S. 6:1054(D).

20           Section 4. In applying and construing the provisions of the Chapter established in  
21 this Act, consideration may be given to the need to promote uniformity of the law with  
22 respect to its subject matter among states.

23           Section 5. If any provision of this Act or the application thereof is held invalid, such  
24 invalidity shall not affect other provisions or applications of this Act which can be given  
25 effect without the invalid provisions or applications, and to this end the provisions of this  
26 Act are hereby declared severable.

27           Section 6. The Louisiana State Law Institute is hereby authorized and directed to  
28 recodify the provisions of Title 6, Chapter 13, to designate the newly enacted Sections as  
29 memorialized in Section 2 of this Act, with any non-substantive, technical changes that may  
30 be necessary.

1           Section 7. The Louisiana State Law Institute is hereby directed to change all  
2 references from "Sales of Checks and Money Transmission Act" to "Louisiana Money  
3 Transmission Act" throughout the Louisiana Revised Statutes of 1950.

4           Section 8. This Act shall become effective July 1, 2026.
