## APPROPRIATIONS/SUPPLEML: Appropriates monies from the Higher Education Initiatives Fund for FY 2005-2006 to the Board of Regents and provides with respect to allocation thereof (Item #30)

1 AN ACT 2 To provide for supplemental appropriations for the Board of Regents out of the State 3 General Fund by Statutory Dedications from the Higher Education Initiatives Fund 4 for Fiscal Year 2005-2006; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. The sum of Ten Million and No/100 (\$10,000,000.00) Dollars is hereby 7 appropriated out of the State General Fund by Statutory Dedications from the Higher 8 Education Initiatives Fund for Fiscal Year 2005-2006 to the Board of Regents, 19-671, for 9 the provision of performance incentives in support of institutional efforts to achieve the 10 goals and objectives of the Master Plan for Postsecondary Education and for continued 11 growth and development of community and technical colleges and learning centers. Such 12 monies shall be allocated by the Board of Regents, which shall submit the proposed 13 allocation of same to the Joint Legislative Committee on the Budget for review and approval 14 prior to the distribution of funds. Further, in the determination of the amount of each 15 institution's allocation, the existence of other appropriations in this fiscal year for the benefit 16 of a specific institution shall not be a factor in the determination of that institution's 17 allocation from monies appropriated herein. 18 Section 2. The appropriation contained in this Act shall supersede any existing

- 2 existing appropriations shall be null, void, and of no effect on the effective date of this Act.
- 3 Section 3. This Act shall become effective upon signature by the governor or, if not
- 4 signed by the governor, upon expiration of the time for bills to become law without signature
- 5 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 6 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 7 effective on the day following such approval.

**Abstract:** Appropriates monies from the Higher Education Initiatives Fund for FY 2005-2006 to the Board of Regents and provides with respect to allocation thereof.

Provides supplemental appropriations for FY 2005-2006 to the Board of Regents out of the Higher Education Initiatives Fund in the amount of \$10,000,000 for provision of performance incentives in support of institutional efforts to achieve the goals and objectives of the Master Plan for Postsecondary Education and for continued growth and development of community and technical colleges and learning centers.

Further provides that the allocation of such monies among recipient postsecondary educational institutions shall be submitted by the Board of Regents to the Joint Legislative Committee on the Budget for approval prior to distribution. <u>Further</u>, directs that the existence of specific appropriations for the benefit of a particular institution shall not be a factor in determination of that institution's allocation from monies appropriated from the Higher Education Initiatives Fund pursuant to this Act.

Provides that appropriations contained in this Act shall supersede any existing appropriations from the Higher Education Initiatives Fund to the Board of Regents for purposes of provision of performance incentives in support of institutional efforts to achieve the goals and objectives of the Master Plan for Postsecondary Education and for continued growth and development of community and technical colleges and learning centers, which existing appropriations shall be null, void, and of no effect on the effective date of this Act.

Effective upon signature of governor or lapse of time for gubernatorial action.
