AN ACT

2 To provide for reductions to certain appropriations from the State General Fund and other 3 funds for Fiscal Year 2005-2006; to reduce appropriations for support of the Office 4 of Urban Affairs and Development and the Office of Rural Development; and to 5 provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. Appropriations out of the State General Fund (Direct) and the State 8 General Fund by Statutory Dedications out of the Rural Development Fund for Fiscal Year 9 2005-2006 for 01-100 EXECUTIVE OFFICE for support of the Office of Urban Affairs and 10 Development and the Office of Rural Development which were unobligated and unexpended 11 as of August 29, 2005, shall be null, void, and of no effect on the effective date of this Act. 12 Section 2. Appropriations out of the State General Fund (Direct) for Fiscal Year 13 2005-2006 for 20-XXX FUNDS for deposit into the Rural Development Fund for the Rural 14 Development Program, which were unobligated and unexpended as of August 29, 2005, 15 shall be null, void, and of no effect on the effective date of this Act. 16 Section 3. This Act shall become effective upon signature by the governor or, if not 17 signed by the governor, upon expiration of the time for bills to become law without signature 18 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 19 vetoed by the governor and subsequently approved by the legislature, this Act shall become 20 effective on the day following such approval.
