TAX/HOTEL OCCUPANCY: Removes the exemption of certain rooms from the hotel occupancy tax in certain parishes

AN ACT

2	To amend and reenact R.S. 33:2711.9(B)(3) and to repeal R.S. 33:4574.1(A)(1)(d),
3	4574.1.1(E), $4574.9(C)(1)(d)$ , $4574.12(D)(1)(d)$ , $4574.13(C)(1)(d)$ , and
4	4575.3(20)(d), relative to hotel occupancy taxes; to delete the exemption of certain
5	rooms from hotel occupancy tax in certain parishes; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 33:2711.9(B)(3) is hereby amended and reenacted to read as follows:
9	§2711.9. Tax authorized; Iberia Parish

13	(3) The tax shall be paid by the person who exercises or is entitled to
14	occupancy of the hotel room or camping facility and shall be paid at the time the rent
15	or fee for occupancy is paid. The tax shall not apply to the rent for hotel rooms
16	rented to the same occupant for a period of thirty or more consecutive calendar days,
17	nor shall it apply to hotel rooms rented for less than three dollars a day, or those
18	hotel rooms rented on an annual contract basis for consecutive or nonconsecutive

- 1 Section 2. R.S. 33:4574.1(A)(1)(d), 4574.1.1(E), 4574.9(C)(1)(d), 4574.12(D)(1)(d),
- 2 4574.13(C)(1)(d), and 4575.3(20)(d) are hereby repealed in their entirety.
- 3 Section 3. This Act shall become effective upon signature by the governor or, if not
- 4 signed by the governor, upon expiration of the time for bills to become law without signature
- 5 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 6 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 7 effective on the day following such approval.

**Abstract:** Deletes the exemption of certain hotel rooms from the hotel occupancy tax in certain parishes.

<u>Present law</u> authorizes the governing authority of Iberia Parish to levy and collect a tax upon the occupancy of hotel rooms and overnight camping facilities located within the parish. Provides that the tax shall be 2% of the rent or fee charged for such occupancy and provides that the tax shall not apply to hotel rooms rented for less than \$3 a day.

#### Proposed law retains present law.

<u>Present law</u> further provides that the tax shall not apply to the rent for hotel rooms rented to the same occupant for a period of 30 or more consecutive calendar days nor to hotel rooms rented on an annual basis for consecutive or nonconsecutive days.

#### Proposed law repeals present law.

<u>Present law</u> authorizes the governing authority of any parish to form and create a tourist commission or by agreement with the governing authority of any other parish to combine two or more parishes or parts thereof into a single tourist commission with such name(s) as the governing authority(ies) may designate.

# Proposed law retains present law.

<u>Present law</u> further provides that in order to provide funds for the operation of the commission, the governing authority(ies) of the parish(es) creating the commission are authorized and empowered to levy and collect a tax upon the occupancy of hotel rooms, motel rooms, and overnight camping facilities within the jurisdiction of the commission. Provides that the tax shall not exceed 2% of the rent of fee charged for such occupancy. Provides for exceptions.

## Proposed law retains present law.

<u>Present law</u> provides that the tax shall not apply to the rent for hotel rooms rented to the same occupant for a period of 30 or more calendar days or those hotel rooms rented on an annual contract basis for consecutive or nonconsecutive days.

### Proposed law repeals present law.

<u>Present law</u> creates and provides for the Concordia Parish Tourist Commission, the East St. Tammany Events Center District, the Madison Parish Tourist Commission, and the River Parishes Convention, Tourist, and Visitors District. Authorizes the governing authority of each commission/district to levy and collect a tax upon the occupancy of hotel rooms, motel rooms, and overnight camping facilities within the jurisdiction of each commission/district in order to provide funds for the operation of each such commission/district.

#### Proposed law retains present law.

<u>Present law</u> provides that the tax shall not apply to the rent for hotel rooms rented to the same occupant for a period of 30 or more calendar days or those hotel rooms rented on an annual basis for consecutive or nonconsecutive days.

### Proposed law repeals present law.

<u>Present law</u> creates certain tourist commissions as special districts and provides that each such commission shall be a body politic and corporate and a political subdivision of the state. Provides that the commissions shall be composed as follows:

- (1) Acadia Parish Convention and Visitors Bureau composed of all the territory in Acadia Parish.
- (2) Alexandria/Pineville Area Convention and Visitors Bureau composed of all the territory in Rapides Parish.
- (3) Allen Parish Tourist Commission composed of all the territory in Allen Parish.
- (4) Ascension Parish Tourist Commission composed of all the territory in Ascension Parish.
- (5) Avoyelles Parish Tourist Commission composed of all the territory in Avoyelles Parish.
- (6) Baton Rouge Area Convention and Visitors Bureau composed of all the territory in East Baton Rouge Parish.
- (7) Beauregard Tourist Commission composed of all the territory in Beauregard Parish.
- (8) Cameron Parish Tourist Commission composed of all the territory in Cameron Parish.
- (9) DeSoto Parish Tourist Bureau composed of all the territory in DeSoto Parish.
- (10) East Carroll Parish Tourist Commission composed of all the territory in East Carroll Parish.
- (11) East Feliciana Parish Tourist Commission composed of all the territory in East Feliciana Parish.
- (12) Franklin Parish Tourism Commission composed of all the territory in Franklin Parish.
- (13) Grant Parish Tourist Commission composed of all the territory in Grant Parish.
- (14) Houma Area Convention and Visitors Bureau composed of all the territory in Terrebonne Parish.

- (15) Iberia Parish Tourist Commission composed of all the territory in Iberia Parish.

- (31) St. Martin Parish Tourist Commission composed of all the territory in St. Martin Parish.

- (43) A convention and visitor's bureau or commission in any parish having a population of not less than 135,000 and not more than 175,000 persons as of the July 1, 1998, population estimate by the U.S. Bureau of the Census

### Proposed law retains present law.

<u>Present law</u> authorizes each commission created as a special district to levy and collect a tax upon the occupancy of hotel rooms, motel rooms, and overnight camping facilities within the jurisdiction of the commission. Provides maximum rates for each commission and provides that for each 1% levied by each commission, 1% levied by the parish governing authority shall be eliminated.

# Proposed law retains present law.

<u>Present law</u> provides that the tax shall not apply to the rent for hotel rooms rented to the same occupant for a period of 30 or more calendar days or those hotel rooms rented on an annual contract basis for consecutive or nonconsecutive days.

### Proposed law repeals present law.

Effective upon signature of governor or lapse of time for gubernatorial action.
