TAX/AD VALOREM TAX Provides for a change of the time and date when the assessor of Orleans Parish has to complete the work on preparing and making up the assessment lists for the year 2005 (Item #42)

Purpose of Bill: Present law requires that assessors in Orleans Parish shall prepare and make up assessment lists for the following calendar year by August 1st each year. This measure provides, for 2005 only, that Orleans Parish assessors shall prepare and make up assessment lists by December 31, 2005.
