FISCAL CONTROLS. Provides with respect to deadlines and requirements for the FY 2006-2007 budget. (gov sig)

| 2 | To suspend and otherwise to make of no effect, for purposes of Fiscal Year 2006-2007, |

| 7 | Be it enacted by the Legislature of Louisiana: |
| 8 | Section 1. For purposes of Fiscal Year 2006-2007, the provisions of R.S. |
| 9 | 39:33(A)(1) requiring submission of budget requests by state agencies no later than the |
| 10 | fifteenth day of November are suspended and of no effect. For purposes of the Fiscal |
| 11 | Year 2006-2007 budget, the commissioner of administration is authorized to establish |
| 12 | a due date for submission of budget requests which is later than the fifteenth day of |
| 13 | November and which in his discretion is more appropriate for the development of the |
| 14 | Fiscal Year 2006-2007 executive budget. |
| 15 | Section 2. For purposes of the Fiscal Year 2006-2007 budget, the provisions of |
| 16 | R.S. 39:37 requiring that the governor submit his executive budget to the Joint |
| 17 | Legislative Committee on the Budget no later than forty-five days prior to each regular |

be submitted to the Joint Legislative Committee on the Budget no later than fifteen days following the submission of the executive budget are suspended and of no effect.

For purposes of the Fiscal Year 2006-2007 budget, the governor shall submit his executive budget to the Joint Legislative Committee on the Budget no later than twenty-one days prior to the 2006 Regular Session of the Legislature, and the written copy of the supporting document shall be submitted to the Joint Legislative Committee on the Budget no later than seven days following the submission of the executive budget.

Section 3. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

effective on the day following such approval.

For purposes of the Fiscal Year 2006-2007 budget, suspends the provisions of R.S. 39:33(A)(1) requiring submission of budget requests by state agencies no later than November 15th. Instead the commissioner of administration is authorized to establish a due date for submission of budget requests which is later than November 15th.

For purposes of the Fiscal Year 2006-2007 budget, suspends the provisions of R.S. 39:37 requiring that the governor submit his executive budget to the Joint Legislative Committee on the Budget no later than 45 days prior to each regular session of the legislature, and requiring that a written copy of the supporting document be submitted to the Joint Legislative Committee on the Budget no later than 15 days following the submission of the executive budget. Instead the governor is required to submit his executive budget to the Joint Legislative Committee on the Budget no later than 21 days prior to the 2006 Regular Session of the Legislature, and the written copy of the supporting document must be submitted to the Joint Legislative Committee on the Budget no later than seven days following the submission of the executive budget.
