CONSUMERS/PROTECTION: Prohibits discrimination on terms for contracts for certain displaced persons as an unfair trade practice

2 To enact R.S. 51:1422, relative to unfair trade practices; to prohibit contracts with displaced 3 persons for less advantageous terms than with consumers who are domiciled in the 4 vicinity of the persons' or entities' principal place of business; to provide for 5 penalties; to provide for an effective date; and to provide for related matters. Be it enacted by the Legislature of Louisiana: 6 7 Section 1. 51:1422 is hereby enacted to read as follows: 8 §1422. Unfair acts or practices; service contracts; certain displaced persons 9 A. It shall be unlawful for any person or entity to contract with displaced 10 persons for less advantageous terms than with consumers who are domiciled in the 11 vicinity of persons' or entities' principal place of business. 12 B. For purposes of this Section, the term "displaced person" shall mean a 13 person who is temporarily located in an area other than his normal domicile due to 14 a gubernatorially declared disaster or emergency. 15 C.(1) Any violation of this Section shall be an unfair trade practice and shall 16 subject the violator to any and all actions and penalties provided for in this Chapter. 17 (2) In addition to any other civil remedies provided for by law, any violation of this Section shall cause the immediate rescission of the contract. 18 19 Section 2. This Act shall become effective upon signature by the governor or, if not 20 signed by the governor, upon expiration of the time for bills to become law without signature

Abstract: Prohibits discrimination on terms for contracts for certain displaced persons.

<u>Proposed law</u> provides that it shall be unlawful for any person or entity to contract with displaced persons for less advantageous terms than with consumers who are domiciled in the vicinity of persons' or entities' principal place of business.

<u>Proposed law</u> provides that, in addition to the penalties provided for in the Unfair Trade Practices and Consumer Protection Law, any violation of <u>proposed law</u> shall cause the immediate rescission of the contract.

Effective upon signature of governor or lapse of time for gubernatorial action.
