2	To enact R.S. 40:2009.4(A)(6), 2109(B)(1)(c), and 2180.2(10), relative to minimum
3	standards for licensure for hospitals, nursing facilities, and intermediate care
4	facilities for the mentally retarded; to provide the Department of Health and
5	Hospitals the authority to promulgate rules for facilities located in areas subject to
6	hurricanes, tidal surges, or flooding; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 40:2009.4(A)(6), 2109(B)(1)(c), and 2180.2(10) are hereby enacted
9	to read as follows:
10	§2009.4. Standards prescribed
11	A. The Department shall prescribe and publish minimum standards in
12	relation to:

14	(6) The establishment, reestablishment, or continued operation of facilities
15	located in areas subject to hurricanes, tidal surges, or flooding. The regulations
16	adopted by the department shall include but not be limited to:

18	The department shall promulgate, in accordance with the Administrative
19	Procedure Act, licensing standards, rules, and regulations, regarding, but not limited
20	to the following:

23	located in areas subject to hurricanes, tidal surges, or flooding. The regulations
24	adopted by the department shall include but not be limited to:

1	(c) Provisions for the fair allocation of the Medicaid share of facility specific

5	Section 2. This Act shall become effective upon signature by the governor or, if not
6	signed by the governor, upon expiration of the time for bills to become law without signature
7	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
8	vetoed by the governor and subsequently approved by the legislature, this Act shall become
9	effective on the day following such approval.
