1	AN ACT
2	To amend and reenact R.S. 27:353(4), 354, and 361(B)(4)(a)(i) and (ii) and to enact R.S.
3	4:147.2, relative to slot machine gaming at live horse racing facilities; to amend the
4	definition of an eligible facility to provide that the Louisiana State Racing
5	Commission can approve less than eighty days within a twenty-week period in
6	certain emergencies or disasters or other such occurrences; to provide for the effect
7	of this determination; to provide relative to the powers and authority of the Louisiana
8	State Racing Commission; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 27:353(4), 354, and 361(B)(4)(a)(i) and (ii) are hereby amended and
11	reenacted to read as follows:
12	§353. Definitions
13	When used in this Chapter, the following terms shall have these meanings:
14	* * *
15	(4) "Eligible facility" means no more than one facility in St. Landry Parish,
16	Bossier Parish, Orleans Parish, and Calcasieu Parish at which the Louisiana State
17	Racing Commission has licensed the conduct or at which the commission has
18	approved the future licensing of the conduct of not less than eighty days within a
19	consecutive twenty-week period each year of live horse race meetings, unless the
20	commission approves the conduct of less than eighty days within a consecutive
21	twenty-week period or a different consecutive or nonconsecutive period, whenever
22	an eligible facility is prevented from conducting live racing as a result of a natural
23	disaster, an act of God, force majeure, a catastrophe, or such other occurrence over

1	which the eligible facility has no control. Such a determination by the commission
2	shall not adversely affect the status of the eligible facility to conduct slot machine
3	gaming. For the 2005 racing season, "eligible facility" shall also include the facility
4	in St. Landry Parish that will not be able to meet such requirements due to repairs or
5	construction to the racetrack which are necessary in order to protect the safety of
6	riders and thoroughbred racehorses and to preserve the revenues to be received and
7	distributed to the state and local governments at such facility or as otherwise
8	provided in R.S. 4:214.1.
9	§354. Power of Louisiana State Racing Commission
10	Nothing in this Chapter shall be construed to abrogate, limit, or affect
11	diminish in any way the powers granted to the Louisiana State Racing Commission.
12	* * *
13	§361. Conduct of slot machine gaming; temporary conduct
14	* * *
15	B. As a condition of licensing and to maintain continued authority for the
16	conduct of slot machine gaming at the licensed eligible facility, the owner of the
17	licensed eligible facility shall:
18	* * *
19	(4) Contribute to the support of pari-mutuel wagering facilities in the state
20	at large and the horse breeding industry by paying annually from the annual net slot
21	machine proceeds received from slot machine gaming operations at the licensed
22	eligible facility as provided in this Paragraph:
23	(a) The licensed eligible facility shall pay a fixed percentage of fifteen
24	percent of the annual net slot machine proceeds received from slot machine gaming
25	operations at the licensed eligible facility to supplement purses as follows:
26	(i) Seventy percent to supplement purses for thoroughbred races at that
27	facility or any facility licensed by the Louisiana State Racing Commission to conduct
28	additional or substitute races or race days as authorized by R.S. 4:147.1, thirty
29	percent of which shall be for Louisiana-bred thoroughbred horses. Four percent of

1	this amount shall go to the Horsemen's Benevolent and Protective Association in
2	accordance with law.
3	(ii) Thirty percent to supplement purses for quarter horse races at that facility
4	or any facility licensed by the Louisiana State Racing Commission to conduct
5	additional or substitute races or race days as authorized by R.S. 4:147.1, sixty
6	percent of which shall be for Louisiana-bred quarter horses. Four percent of this
7	amount shall go to the Horsemen's Benevolent and Protective Association in
8	accordance with law.
9	* * *
10	Section 2. R.S. 4:147.2 is hereby enacted to read as follows:
11	§147.2. Additional powers of commission; force majeure
12	The powers of the commission shall include but not be limited to the
13	discretion to approve the conduct of less than eighty days within a consecutive
14	twenty-week period or a different consecutive or nonconsecutive period, whenever
15	an eligible facility is prevented from live racing as a result of a natural disaster, an
16	act of God, force majeure, a catastrophe, or such other occurrence over which the
17	licensee has no control.
18	Section 3. This Act shall become effective upon signature by the governor or, if not
19	signed by the governor, upon expiration of the time for bills to become law without signature
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
21	vetoed by the governor and subsequently approved by the legislature, this Act shall become
22	effective on the day following such approval.
