SENATE RESOLUTION NO. 6

COURTS. Urges and requests the Louisiana Supreme Court to adopt the same financial disclosure standards for judges applicable to elected officials in the Code of Governmental Ethics.

A RESOLUTION

2	To urge and request the Louisiana Supreme Court to adopt the same financial disclosure
3	standards for judges that are applicable to other elected officials in the Code of
4	Governmental Ethics.
5	WHEREAS, Article V of the Louisiana Constitution of 1974 sets forth the powers
6	and duties of the judicial branch of government; and
7	WHEREAS, in such Article the state supreme court is vested with general
8	supervisory jurisdiction over all other courts; and
9	WHEREAS, the supreme court is further vested with exclusive original jurisdiction
10	in judicial disciplinary proceedings; and
11	WHEREAS, the judiciary commission is created to provide recommendations to the
12	supreme court concerning discipline of judges; and
13	WHEREAS, the supreme court, pursuant to its supervisory authority over all lower
14	courts, has adopted the Code of Judicial Conduct; and
15	WHEREAS, such Code of Judicial Conduct is binding on all judges, and violations
16	of its Canons can serve as the basis for disciplinary action; and
17	WHEREAS, the supreme court has stated that the primary purpose of the Code of
18	Judicial Conduct is to protect the public rather than to discipline judges (In re Shea, 815

1	So.2d 813, 815 (La. 2002)), and that the duty of the supreme court pursuant to its
2	constitutional responsibility is to preserve the integrity of the bench for the benefit of the
3	public "by ensuring that all who don the black robe and serve as ministers of justice do not
4	engage in public conduct which brings the judicial office into disrepute" (In re Huckaby, 656
5	So.2d 292, 298 (La. 1995)); and
6	WHEREAS, judges are not presently included within the statutory requirements of
7	the code of governmental ethics and La. R.S. 42:1167 presently states, "All judges, as
8	defined by the Code of Judicial Conduct, shall be governed exclusively by the provisions of
9	the Code of Judicial Conduct, which shall be administered by the Judiciary Commission
10	provided for in Article V, Section 25 of the Constitution of Louisiana."; and
11	WHEREAS, Canon 6 of the Code of Judicial Conduct requires judges to file with the
12	supreme court certain annual reports and disclosure statements concerning compensation and
13	expenses received in connection with any quasi-judicial activity; and
14	WHEREAS, Canon 7 of the Code of Judicial Conduct provides generally that a judge
15	or judicial candidate shall refrain from inappropriate political activity, and further sets forth
16	certain duties and prohibitions for judges as to political conduct and activity, campaign
17	conduct, campaign committees, and retention of campaign contributions; and
18	WHEREAS, it would greatly benefit the public interest for the Code of Judicial
19	Conduct to include financial disclosure standards and requirements for judges that are
20	consistent with requirements for other elected officials set forth in the Code of Governmental
21	Ethics; and
22	WHEREAS, such consistency would strengthen the Code of Judicial Conduct and
23	result in significant requirements to ensure the protection of the public and integrity of the
24	judiciary in Louisiana.
25	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
26	does hereby urge and request the Louisiana Supreme Court to adopt the same financial
27	disclosure standards for judges that are applicable to other elected officials in the Code of
28	Governmental Ethics.
29	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the

chief justice of the Louisiana Supreme Court.
